The Parking Places and Controlled Parking Zone (Liverpool) (Order 2009) (Variation No.44) Order, 2013

The City Council of Liverpool (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, 2, 3, 4, 9, 19, 32, 35, 38, 45, 46, 47, 48, 49, 50, 51, 52, 53 and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Experimental Traffic Regulation Order:-

1. Commencement and Citation

- (a) This Order shall come into operation on the 26th day of November 2013 and may be cited as The Parking Places And Controlled Parking Zone (Liverpool) (Order 2009) (Variation No.44) Order, 2013.
- (b) This Order shall make permanent the effect of **The Parking Places And Controlled Parking Zone** (Liverpool) (Order 2009) (Experimental Variation No.44) Order, 2012, that was initially made under **Section 9** of the Act of 1984 and came into operation on the 29th day of **May 2012** for a maximum period of up to eighteen months and which would have expired on the 26th day of **November 2013**.

2. Interpretation

- (1) In this **Experimental Traffic Regulation Order** except where the context otherwise requires, the several words and expressions for which meanings are assigned by the Order of 2009 shall have the same respective meaning.
- (2) Furthermore, in this Order the expression "Order of 2009" means The Parking Places And Controlled Parking Zone (Liverpool) Order 2009, as amended.

<u>Variation Of The Order Of 2009 As Respects Roads And Parts Of Roads In Which Waiting Is Prohibited Twenty-Four Hours A Day</u>

- 3. The Order of 2009 shall have effect as though in Schedule 15: -
- (a) The existing inner zone roads numbered 170A, 170B and 170C were omitted from the Order as specified in Schedule 1 to this Order.
- (b) The new inner zone road numbered 170 was included as specified in Schedule 2 to this Order.

<u>Variation Of The Order Of 2009 As Respects Roads And Parts Of Roads In Which Loading and Unloading Is Prohibited Between The Hours Of 8.30 a.m. and 9.30 a.m. and Between The Hours Of 4.30 p.m. and 6.00 p.m.</u>

4. The Order of 2009 shall have effect as though in **Schedule 17** the existing inner zone road numbered 170 was omitted from the Order as specified in **Schedule 3** to this Order.

<u>Variation Of The Order Of 2009 As Respects Roads And Parts Of Roads In Which Loading and Unloading Is Prohibited At Any Time</u>

- 5. The Order of 2009 shall have effect as though in Schedule 18: -
- (a) The existing inner zone roads numbered 170A, 170B and 170C were omitted from the Order as specified in Schedule 4 to this Order.
- (b) The new inner zone road numbered 170 was included as specified in Schedule 5 to this Order.
