**The Parking Places and Controlled Parking Zone
(Liverpool) (Order 2009) (Variation No.45)
Order, 2014**

The City Council of Liverpool (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, 2, 3, 4, 9, 19, 32, 35, 38, 45, 46, 47, 48, 49, 50, 51, 52, 53 and Part IV of Schedule 9 of The Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. Commencement and Citation

(a) This Order shall come into operation on the 10th day of January 2014 and may be cited as **The Parking Places and Controlled Parking Zone (Liverpool) (Order 2009) (Variation No.45) Order, 2014.**

(b) This Order shall make permanent the effect of **The Parking Places and Controlled Parking Zone (Liverpool) (Order 2009) (Experimental Variation No.45) Order, 2012**, that was initially made under Section 9 of the Act of 1984 and came into operation on the 13th day of July 2012 for a maximum period of up to eighteen months and which would have expired on the 10th day of January 2014.

2. Interpretation

(1) In this Order except where the context otherwise requires, the several words and expressions for which meanings are assigned by the Order of 2009 shall have the same respective meaning.

(2) Furthermore, in this Order the expression "Order of 2009" means **The Parking Places and Controlled Parking Zone (Liverpool) Order 2009**, as amended.

Part I – Inner Zone

3. The Order of 2009 shall have effect as though in **Schedule 1: -**

(a) The existing inner zone roads numbered **173B** and **173C** were omitted from the Order as specified in **Schedule 1** to this Order.

(b) The new inner zone roads numbered **173B** and **173C** were included as specified in **Schedule 2** to this Order.

Variation Of The Order Of 2009 As Respects Areas Of Highways Designated As Parking Places For Vehicles For Loading And Unloading

4. The Order of 2009 shall have effect as though in **Schedule 3** the new inner zone roads numbered **173A** and **173B** were included as specified in **Schedule 3** to this Order.

Variation Of The Order Of 2009 As Respects Roads And Parts Of Roads In Which Waiting Is Prohibited Between The Hours Of 8.00 a.m. and 6.00 p.m. On Mondays To Sundays

5. The Order of 2009 shall have effect as though in **Schedule 14: -**

(a) The existing inner zone road numbered **173** was omitted from the Order as specified in **Schedule 4** to this Order.

(b) The new inner zone road numbered **173** was included as specified in **Schedule 5** to this Order.

Variation Of The Order Of 2009 As Respects Roads And Parts Of Roads In Which Waiting Is Prohibited Twenty-Four Hours A Day

6. The Order of 2009 shall have effect as though in **Schedule 15**: -

(a) The existing inner zone roads numbered **173A**, **173B** and **173E** were omitted from the Order as specified in **Schedule 6** to this Order.

(b) The new inner zone roads numbered **173A**, **173B**, **173E** and **173F** were included as specified in **Schedule 7** to this Order.

Variation Of The Order Of 2009 As Respects Roads And Parts Of Roads In Which Loading and Unloading Is Prohibited At Any Time

7. The Order of 2009 shall have effect as though in **Schedule 18**: -


(a) The existing inner zone roads numbered **173A**, **173B** and **173E** were omitted from the Order as specified in **Schedule 8** to this Order.

(b) The new inner zone roads numbered **173A**, **173B**, **173E** and **173F** were included as specified in **Schedule 9** to this Order.


Variation Of The Order Of 2009 As Respects Areas of Highway Designated As Hackney Carriage Clearways (Inner Zone)
