



TRAFFIC REGULATION ORDER AND HACKNEY CARRIAGE STAND PROPOSAL AFFECTING THE ALLERTON ROAD DISTRICT SHOPPING CENTRE AREA

Notice is hereby given that The City Council of Liverpool proposes to make the below-mentioned Order under Sections 1(1) and (2), 2(1) to (3), 4(2) and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984, the effect of which will be: -

1. The City Council Of Liverpool (Allerton Road District Shopping Centre) (Revocation And Prohibition And Restriction Of Waiting) Order, 2003 (Ref: - LS/P&EU/P&CG/NRB/TRO N° 3492.1109.???/HDC TRO TM N°2416): -

(1) To revoke The City Council of Liverpool (Allerton Road District Shopping Centre) (Revocation, One-Way Traffic, Prohibition and Restriction of Waiting, Prohibition of Loading and Unloading and Prohibition of "U"-Turns) (Order, 1995) (Amendment) Order, 1998, in so far as it relates to waiting between the hours of 7.00 a.m and 7.00 p.m. on: - (a) Allerton Road Shops Service Road (between N° 118-192) from a point 5 metres south east of its junction with Garthdale Road; and (b) Allerton Road (southwest side) - from a point 5 metres south east of its junction with Garthdale Road, in a south easterly direction, to a point 5 metres north west of its junction with the south eastern end of the Allerton Road Shops Service Road.

(2) To revoke The City Council of Liverpool (Allerton Road District Shopping Centre) (Revocation, One-Way Traffic, Prohibition and Restriction of Waiting, Prohibition of Loading and Unloading and Prohibition of "U"-Turns) Order, 1995, in so far as it relates to waiting at any time on Mather Avenue, its southwest side: - (a) from a point 129 metres south of its junction with Rose Lane, in a northerly direction, to a point 57 metres north of the said junction; (b) from its junction with the Allerton Road Shops Service Road, in a south easterly direction, for a distance of 5 metres.

(3) To prohibit, with certain, exceptions, any vehicle from waiting at any time on Mather Avenue, its south west side, from a point 129 metres south of its junction with Rose Lane, in a northerly direction, as far as its junction with the Allerton Road Shops Service Road.

(4) To prohibit, with certain, exceptions, any vehicle to wait between the hours of 7.00 a.m. and 6.00 p.m. on any day on Allerton Road, its south west side, from a point 5 metres south east of its junction with Garthdale Road, in a south easterly direction, to a point 5 metres north west of its junction with the south eastern end of the Allerton Road Shops Service Road: - (i) for a longer period than two hours; or (ii) if a period of less than one hour has elapsed since the termination during the said hours of the last period of waiting (if any) by the vehicle on the same side of length of road.

The exceptions referred to will enable a vehicle to wait for so long as is necessary:- (a) to enable a person to board or alight from the vehicle; (b) to enable the vehicle to be used in connection with any wedding or funeral, any building, industrial or demolition operations, the removal of any obstruction to traffic, the maintenance of the road or the services therein; (c) to enable the vehicle to be used for fire brigade, ambulance or police purposes; (d) to enable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said road or lengths of roads; (e) to enable the vehicle to be used by a disabled person in accordance with the Orange or Blue Badge Schemes; and (f) to enable goods to be loaded on to or unloaded from the vehicle.
