The City Council of Liverpool (North – Part 1 Stationary Vehicle Offences) (Consolidation) (Order 2006) (Variation N°119) Order 2015

The City Council of Liverpool (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, 2, 4, 19, 32, 35, 38, 45, 46, 49, 53 and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") as amended by The Road Traffic (Parking) Act 1986 (hereinafter referred to as "the Act of 1986") and Section 43 of Schedule 3 of The Road Traffic Act 1991 (hereinafter referred to as "the Act of 1991") and of all other enabling powers and after consultation with the Chief Officer of Police, the Traffic Commissioner for the North West and the Merseyside Passenger Transport Executive in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order: -

Section One - Commencement, Citation, Interpretations and General Articles

- 1. This Order shall come into operation on the 6^{th} day of April 2015 and may be cited as: The City Council of Liverpool (North Part 1 Stationary Vehicle Offences) (Consolidation) (Order 2006) (Variation N°119) Order 2015.
- 2. In this Order except where the context otherwise requires, the several words and expressions for which meanings are assigned by the Order of 2006 shall have the same respective meaning.
- 3. In this Order the expression "Order of 2006" means The City Council of Liverpool (North Part 1 Stationary Vehicle Offences) (Consolidation) Order, 2006, as amended.
- 4. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- 5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

<u>Variation Of The Order Of 2006 As Respects Roads/Grass Verges (Where Specified) And Parts Of Roads/Grass Verges (Where Specified) In Which Waiting Is Prohibited Twenty Four Hours A Day</u>

- 6. The Order of 2006 shall have effect as though in Schedule 15: -
- (a) The existing roads were omitted from the Order as specified in **Schedule 1** to this Order.
- (b) The new road was included as specified in **Schedule 2** to this Order.

<u>Variation Of The Order Of 2006 As Respects Roads And Parts Of Roads In Which Waiting Is</u> <u>Prohibited At Certain Times</u>

7. The Order of 2006 shall have effect as though in **Schedule 16** the existing roads were omitted from the Order as specified in **Schedule 3** to this Order.

Variation Of The Order Of 2006 As Respects Roads/Grass Verges (Where Specified) And Parts Of Roads/Grass Verges (Where Specified) In Which Loading And Unloading Is Prohibited Twenty Four Hours A Day

8. The Order of 2006 shall have effect as though in **Schedule 17** the new roads were included as specified in **Schedule 4** to this Order.

<u>Variation Of The Order Of 2006 As Respects Roads And Parts Of Roads In Which Loading And Unloading Is Prohibited At Certain Times</u>

- 9. The Order of 2006 shall have effect as though in Schedule 18: -
- (a) The existing roads were omitted from the Order as specified in **Schedule 5** to this Order.

(b) The new roads were included as specified in **Schedule 6** to this Order.
