(IM Marsh Campus Area - Permitted Parking Area) (Various Roads) (Revocation, Residents Parking Places, Coach Parking Places, Prohibition of Waiting) (Order, 2013) (Amendment) Order 2015

The City Council of Liverpool (hereinafter referred to as "the Council") in exercise of its powers under Sections 1(1) and (2), 2(1) to (3), 4(2), 45 to 53 and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

Section One - Commencement, Citation, Interpretations and General Articles

- 1. This Order shall come into operation on the 20th day of April 2015 and may be cited as: The City Council of Liverpool (IM Marsh Campus Area Permitted Parking Area) (Various Roads) (Revocation, Residents Parking Places, Coach Parking Places, Prohibition of Waiting) (Order, 2013) (Amendment) Order 2015.
- 2. (1) In this Order, save as otherwise previously defined within the **Order of 2013**, each and every expression shall have the meaning assigned to it by **The Traffic Signs Regulations and General Directions 2002**.
- "Order of 2013" means The City Council of Liverpool (IM Marsh Campus Area Permitted Parking Area) (Various Roads) (Revocation, Residents Parking Places, Coach Parking Places, Prohibition of Waiting) Order, 2013.
- 2. (2) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- 3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

Variation Of The Order Of 2013 As Respects The Title Bars Of Schedule Two And Schedule Three

4. The Order of 2013 shall have effect as though the existing Title Bars of Schedule Two (Areas of Highway Designated as Residents Parking Places (Specifically Described As Permitted Parking Areas - PPA) During The Permitted Hours Of 9.00 a.m. To 4.30 p.m. on Mondays To Fridays Inclusive During The Period From The 1st September To The 31st May Inclusive) and Schedule Three (Areas of Highway Designated as Coach Parking Places) were substituted by the new Schedule Two (Areas of Highway Designated as Residents Parking Places (Specifically Described As Permitted Parking Areas - PPA) During The Permitted Hours Of 9.00 a.m. To 4.30 p.m. on Mondays To Fridays Inclusive During The Period From The 1st September To The 31st May Inclusive) and Schedule Three (Areas of Highway Designated as Coach Parking Places) as specified below/overleaf in this Order: -
