The City Council of Liverpool (Lime Street, London Road, Seymour Street, Skelhorne Street Area) (Revocation, Prohibition of Right Turn, Prohibition of Driving, Prohibition of "U"-Turn, One-Way Traffic and Contra-flow Bus Lane) (Order, 2006) (Amendment) Order, 2016

The **City Council of Liverpool** (hereinafter referred to as "**the Council**") in exercise of its powers under **Sections 1, 2, 4 and Part IV of Schedule 9 to The Road Traffic Regulation Act 1984** (which said Act of 1984 is hereinafter referred to as "**the Act of 1984**") and of all other enabling powers and after consultation with the chief officer of police in accordance with **Part III of Schedule 9** to the Act of 1984, hereby makes the following Order:-

Section One – Commencement, Citation, Interpretations & General Articles

1A. This Order shall come into operation on the **23rd** day of **May 2016** and may be cited as: - **The City Council Of Liverpool (Lime Street, London Road, Seymour Street, Skelhorne Street Area) (Revocation, Prohibition Of Right Turn, Prohibition Of Driving, Prohibition Of "U"-Turn, One-Way Traffic and Contra-flow Bus Lane) (Order, 2006) (Amendment) Order, 2016.**

1B. This Order shall make permanent the effect of **The City Council Of Liverpool (Lime Street, London Road, Seymour Street, Skelhorne Street Area) (Revocation, Prohibition Of Right Turn, Prohibition Of Driving, Prohibition Of "U"-Turn, One-Way Traffic and Contra-flow Bus Lane) (Order, 2006) (Experimental Amendment) Order, 2014**, that was initially made under **Section 9** of the Act of 1984 and came into operation on the **24th** day of **November 2014** for a maximum period of up to eighteen months and which would have expired on the **23rd** day of **May 2016**.

2. (1) In this Order, save as otherwise defined within this Order, each and every expression shall have the meaning assigned to it by **The Traffic Signs Regulations and General Directions 2016**: -

"**Order of 2006**" means **The City Council Of Liverpool (Lime Street, London Road, Seymour Street, Skelhorne Street Area) (Revocation, Prohibition Of Right Turn, Prohibition Of Driving, Prohibition Of "U"-Turn, One-Way Traffic and Contra-flow Bus Lane) Order, 2006**;

The **Order of 2006** is hereby amended by the inclusion within its **Article 2.(1)** of the new interpretations as specified below in this Order: -

*"**authorised vehicle**" means a coach, pedal cycle, hackney carriage, licensed private hire vehicle, a vehicle being used by the Police, Ambulance, Fire Service or Statutory Services, Postal Operator and Local Authority in pursuance with their essential duties, a vehicle accessing the St. John's Centre Car Park, or any vehicle being used by Her Majesty's Prison Services or their contractors for the transportation of prisoners.*

*"**licensed private hire vehicle**" has the same meaning as in Section 80(1) of the Local Government (Miscellaneous Provisions) Act 1976. Such a vehicle must be identifiable by a valid license plate being secured to the rear of the exterior of the vehicle, so as to be easily seen.*

*"**St John's Centre Car Park**" – means the multi storey car park within St John's Shopping Centre, in Liverpool City Centre, which has its vehicular entrance on St George's Place.*

2. (3) Except where otherwise stated, any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order.

3. The prohibition and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

Section Two – The Amendments To The Order Of 2006

4. The **Order of 2006** is hereby amended by the substitution of the existing **Article 8(c)** and **Article 11** by the new **Article 8(c)** and **Article 11** as specified below in this Order: -


8. *No person shall cause or permit any vehicle to proceed on: - (a) Skelhorne Street, other than in a westerly direction; (b) St. George's Place (gap in the central reservation), other than in a westerly direction; and (c) Lime Street (from its junction with Elliot Street to its junction with Ranelagh Place) other than in a southerly direction.*

11. *No person shall cause or permit any vehicle, other than a public service vehicle, coach, pedal cycle, hackney carriage, licensed private hire vehicle, a vehicle being used by the Police, Ambulance, Fire Service or Statutory Services, Postal Operator and Local Authority in pursuance with their essential duties, an emergency liveried NHS vehicle, being used for the urgent transportation of blood, tissues and organs, or any vehicle being used by Her Majesty's Prison Services or their contractors for the transportation of prisoners, or a vehicle accessing the St. John's Centre Car Park, to proceed in a northbound direction in the contra-flow bus lane in Lime Street, between the west side kerb line and Traffic Sign to diagram 1049 and from its junction with Ranelagh Place to its junction with Elliot Street, between the hours of 12:00 noon to 6:00pm on Mondays to Saturdays inclusive.*

Section Three – Contravention Of The Order

5. Any person who contravenes the new **Article 8(c)** and **Article 11** of the **Order of 2006** within this Order, or who uses a vehicle, or causes or permits a vehicle to be used in contravention of the new **Article 8(c)** and **Article 11** of the **Order of 2006** within this Order, shall be guilty of an offence.
