The City Council of Liverpool (hereinafter referred to as "**the Council**") in exercise of its powers under **Sections 1, 2, 4, 19, 32, 35, 38, 45, 46, 49, 53** and **Part IV of Schedule 9 to The Road Traffic Regulation Act 1984** (which said Act of 1984 is hereinafter referred to as "**the Act of 1984**") as amended by **The Road Traffic (Parking) Act 1986** (hereinafter referred to as "**the Act of 1986**") and **Section 43 of Schedule 3 of The Road Traffic Act 1991** (hereinafter referred to as "**the Act of 1991**") and of all other enabling powers and after consultation with the Chief Officer of Police, the Traffic Commissioner for the North West and the Merseyside Passenger Transport Executive in accordance with **Part III of Schedule 9** to the Act of 1984, hereby makes the following Order: -

Commencement, Citation and General Articles

1. This Order shall come into operation on the 8th day of August 2016 and may be cited as: - **The City Council of Liverpool (North – Part 1 Stationary Vehicle Offences) (Consolidation) (Order 2006) (Variation N°135) Order, 2016.**
2. In this Order except where the context otherwise requires, the several words and expressions for which meanings are assigned by the Order of 2006 shall have the same respective meaning.
3. In this Order the expression "**Order of 2006**" means **The City Council Of Liverpool (North – Part 1 Stationary Vehicle Offences) (Consolidation) Order, 2006**, as amended.
4. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

Variation Of The Order Of 2006 As Respects Arrangement Of Schedules

6. The Order of 2006 shall have effect as though the **Arrangement of Schedules** included the new **Schedule 19 (Areas of Highway designated as Hackney Carriage Clearways (For Information Only))** as specified below in this Order: -

Variation Of The Order Of 2006 As Respects Article 2 (Interpretations)

7. The Order of 2006 shall have effect as though in **Article 2 (Interpretations)**: -
 - (a) The existing interpretation of "**business parking permit**" was substituted by the new interpretation of "**business parking permit**" as specified below in this Order: -

*"business parking permit (Broad Green Area, Broad Green North Area, Kensington Fields Area, **Northumberland Terrace Area** and Phythian Area)" allows the holder of a valid Business Parking Permit to park on any area of highway in the Broad Green Area, Broad Green North Area, Kensington Fields Area, **Northumberland Terrace Area** and Phythian Area specifically described as such within Schedule 3 to this Order (see Articles 24D-24E on pages ??-?? and Schedule 3).*

(b) The new interpretations of "**Hackney Carriage Clearway**" and "**Northumberland Terrace Area**" was included as specified below in this Order: -

*"**Hackney Carriage Clearway**" means any area described in **Schedule 19** to this Order in which stopping or stopping for the purpose of loading and unloading at any time is prohibited for any vehicle other than a hackney carriage.*

*"**Northumberland Terrace Area**" means the following entire lengths of roads (unless otherwise stated): - Albion Street, Atherton Close, Border Way, Calmet Close, Devonshire Place, Dukes Road, Grecian Terrace, Hackthorpe Street, Hapton Street, Hartnor Close, Jason Street, Jason Walk, Joshua Close, Kirk Street, Mark Street, Medea Close, Mitylene Street, John Bagot Close, Northumberland Terrace, Patmos Close, Staffordshire Close, St Domingo Road, & York Terrace.*

Variation Of The Order Of 2006 As Respects SECTION THREE – WAITING AND LOADING & UNLOADING RESTRICTIONS

8. The Order of 2006 shall have effect as though the new **Article 10A (Hackney Carriage Stands)** was included as specified below in this Order: -

Hackney Carriage Clearways

10A. No person shall cause or permit any vehicle to stop or stop for the purpose of loading or unloading at any time at a Hackney Carriage Clearway during the Permitted Hours other than a Hackney Carriage.

Variation Of The Order Of 2006 As Respects SECTION FOUR – VARIOUS PARKING PLACES

9. The Order of 2006 shall have effect as though the existing **Article 24C (Permitted Parking Area)** and **Articles 24D-E (Business Parking (Broad Green Area, Broad Green North Area and Kensington Fields Area))** was substituted by the new **Article Article 24C (Permitted Parking Area)** and **Articles 24D-E (Business Parking (Broad Green Area, Broad Green North Area, Kensington Fields Area, Northumberland Terrace Area and Phythian Area))** as specified below/overleaf in this Order:-

Permitted Parking Area

*24C. No person shall leave a vehicle in a Permitted Parking Area specifically described as such within Schedule 3 (Residents Parking Places) to this Order during the permitted hours unless he is the holder of a valid Residents Parking Permit, Carers Parking Permit or Visitors Parking Permit, Business Parking Permit (Broad Green Area, Broad Green North Area, Kensington Fields Area, **Northumberland Terrace Area** and Phythian Area), Community Centre Parking Permit (Kensington Fields Area only) or Landlord Parking Permit (Broad Green Area, Broad Green North Area, Kensington Fields Area) in respect of the Permitted Parking Area at which the vehicle is left and he displays such Permit on that vehicle in accordance with Article 32.*

Business Parking (Broad Green Area, Broad Green North Area, Kensington Fields Area, Northumberland Terrace Area and Phythian Area)

24D. No person shall leave a vehicle in a Permitted Parking Area or Residents Parking Place specifically described as such within Schedule 3 (Residents Parking Places) to this Order during the permitted hours unless he is the holder of a valid Business Parking Permit within the Broad Green Area, Broad Green North Area, Kensington Fields Area, **Northumberland Terrance Area** and Phythian Area specified by the Council at which the vehicle is left and he displays such Permit on that vehicle in accordance with Article 32.

24E. The Council may issue a Business Parking Permit permitting a specified vehicle to park during the permitted hours within the Broad Green Area, Broad Green North Area, Kensington Fields Area **Northumberland Terrace Area** and Phythian Area specified by the Council to an applicant who satisfies the Council that he:-

24E.1. is regularly carrying on a business of which he has a controlling interest at premises fronting the Broad Green Area, Broad Green North Area, Kensington Fields Area, **Northumberland Terrace Area** or Phythian Area specified by the Council; and

24E.2. has no suitable parking facility within a reasonable distance of such business premises.

Variation Of The Order Of 2006 As Respects Areas Of Highway Designated As Parking Places Without Charge

9. The Order of 2006 shall have effect as though in **Schedule 2** the new road/footway was included as specified in **Schedule 1** to this Order.

Variation Of The Order Of 2006 As Respects Areas Of Highway Designated As Residents Parking Places

10. The Order of 2006 shall have effect as though in **Schedule 3**: -

(a) The existing road was omitted from the Order as specified in **Schedule 2** to this Order.

(b) The new roads were included as specified in **Schedule 3** to this Order.

Variation Of The Order Of 2006 As Respects Roads/Grass Verges (Where Specified) And Parts Of Roads/Grass Verges (Where Specified) In Which Waiting Is Prohibited Twenty Four Hours A Day

11. The Order of 2006 shall have effect as though in **Schedule 15**: -

(a) The existing roads were omitted from the Order as specified in **Schedule 4** to this Order.

(b) The new roads were included as specified in **Schedule 5** to this Order.

Variation Of The Order Of 2006 As Respects Roads And Parts Of Roads In Which Waiting Is Prohibited At Certain Times

12. The Order of 2006 shall have effect as though in **Schedule 16** the new roads were included as specified in **Schedule 6** to this Order.

Variation Of The Order Of 2006 As Respects Roads/Grass Verges (Where Specified) And Parts Of Roads/Grass Verges (Where Specified) In Which Loading And Unloading Is Prohibited Twenty Four Hours A Day

13. The Order of 2006 shall have effect as though in **Schedule 17**: -


(a) The existing roads were omitted from the Order as specified in **Schedule 7** to this Order.

(b) The new road was included as specified in **Schedule 8** to this Order.

Variation Of The Order Of 2006 As Respects Areas Of Highway Designated As Hackney Carriage Clearways

15. The Order of 2006 shall have effect as though in **Schedule 19** the new roads were included as specified in **Schedule 9** to this Order.
