 - (c) In schedule 1 thereto, the details specified in Part IV, article 10 (2)&(3) charges relating to Pay & Display Parking Places 1,2a,2b,3,4,5,6,7,8 and 9 shall be amended to the prices specified in Schedule 3 to this Order.
 - (d) In Schedule 2 thereto; the details specified in Part V, article 21 (2)a; charges relating to Business Permit Charges shall be amended as follows; if the permit is issued to a person who carries on a business in the Permitted Parking Area, £100 for a year or any part of a year.
- (3) This Order may be cited as "The Kent County Council (Borough of Maidstone) (Designated Parking Places Order) (Variation No. 1) Order 2008" and shall come into operation on the 28th November 2008.
