**VARIATION No.18 ORDER 2019**

**ROAD TRAFFIC REGULATION ACT 1984**

The KENT COUNTY COUNCIL, acting as the local traffic authority and in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49, 53, 122 and 124 of the Road Traffic Regulations Act 1984 (hereinafter called "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby make the following Order:-

**Revocations, Modifications and Amendments**

In this Order the expression "Order of 2017" means "The Kent County Council (Borough of Maidstone) Waiting Restrictions Consolidation Order 2017" shall have effect as though:

**In the Schedules to the Order of 2017**

**FIRST SCHEDULE**  
**STREET OR LENGTH OF STREET**  
**WHERE WAITING IS PROHIBITED AT ANY TIME**

**Roads in Boxley in the Borough of Maidstone**

The following items to be inserted in the First Schedule of Order of 2017.

**BLACKSMITH DRIVE** On both sides from its junction with Provender Way for a distance of 11 metres in a westerly direction.

**FRANKLIN DRIVE** On both sides from its junction with Grovewood Drive South for a distance of 23 metres in a south westerly direction.

**GROVEWOOD DRIVE SOUTH**

On the southern side from a point 6 metres west and 21 metres east of its junction with Franklin Drive.

**HARVESTERS WAY** (1) On the eastern side from its junction with Grovewood Drive South for a distance of 21 metres in a northerly direction.

(2) On the western side from its junction with Grovewood Drive South for a distance of 12 metres in a northerly direction.

**PROVENDER WAY (GROVE GREEN)**

(1) On the north-eastern side

(a) from its north junction with Restharrow Road for a distance of 261 metres in a northerly direction;

(b) from its southern junction with Restharrow Road for a distance of 6 metres in a southerly direction;

(c) from a point 10 metres north-east and 14 metres south-west of its junction with Wingrove Drive.

(2) On the south-western side

(a) from the vehicular entrance to St John's C of E Primary School to its junction with Blacksmith Drive;

(b) from a point 10 metres north and 10 metres south of its junction with Wagoners Close;

(c) from a point 6 metres north and 6 metres south of its junction with Shearers Close;

(d) from its northern junction with Blacksmith Drive for a distance of 10 metres in a northerly direction;

(e) from a point 8 metres north and 6 metres south of its junction with Threshers Drive.

**RESTHARROW ROAD** On both sides from its junction with Provender Way for a distance of 15 metres in an easterly direction.

**SHEARERS CLOSE** On both sides from its junction with Provender Way for a distance of 20 metres in a westerly direction.

**THRESHERS DRIVE** On both sides from its junction with Provender Way for a distance of 18 metres in a westerly direction.

**WAGONERS CLOSE** On both sides from its junction with Provender Way for a distance of 15 metres in a westerly direction.

**WINGROVE DRIVE** On both sides from its junction with Provender Way for a distance of 15 metres in a south easterly direction.

### **Roads in Maidstone in the Borough of Maidstone**

The following items to be inserted in the First Schedule of Order of 2017.

**SPRINGFIELD** (1) On the northern side from its junction with Royal Engineers Road for a distance of 62 metres in a south westerly direction.

(2) On the southern side from its junction with Royal Engineers Road for a distance of 67 metres in a north easterly direction.

(3) Around the entire circumference

(a) of the island at the junction of Springfield and Royal Engineers Road;

(b) of the centre carriageway island of Springfield.

This Order shall come into force on 4<sup>th</sup> day of March 2019 and may be cited as "The Kent County Council (Various Roads, The Borough of Maidstone) (Waiting Restrictions and Street Parking Places) Variation No.18 Order 2019" ('this Order')
