ROAD TRAFFIC REGULATION ACT 1984

The KENT COUNTY COUNCIL, acting as the local traffic authority and in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49, 53, 122 and 124 of the Road Traffic Regulations Act 1984 (hereinafter called "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby make the following Order:-

Revocations, Modifications and Amendments

In this Order the expression "Order of 2017" means "The Kent County Council (Borough of Maidstone) Waiting Restrictions Consolidation Order 2017" and shall have effect as though:
