
[LIMITED WAITING ON COURT ROAD, BARNARDS GREEN, MALVERN]

Worcestershire County Council in exercise of their powers under Section 1(1), 2 (1) to (3), 4(2) and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984") and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

- 1. The Worcestershire County Council (Malvern Hills District) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2013 is hereby varied by the attachment thereto of the plan attached to this Order (which has the effect of imposing on the road and side of road identified in the plan attached to this Order limited waiting 1 hour, no return within 2 hours, between 8.00am and 6.00pm Monday to Saturday in accordance with the provisions of the Consolidation Order).
- The Order shall come into operation on 12 December 2013 and may be cited as Worcestershire County Council (Malvern Hills District) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2013 (Variation) Order 2013 [Limited Waiting on Court Road, Barnards Green, Malvern].
