

**THE CITY OF MANCHESTER (OFF STREET PARKING PLACES)
(MANCHESTER CITY CENTRE) (AMENDMENT) ORDER 2001**

The Council of the City of Manchester in exercise of its powers under Sections 32, 35(1) and Section 35(3) and Part IV of the Road Traffic Regulation Act 1984 and all other enabling powers and after consultation with the Chief Constable of Greater Manchester Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

Citation and Commencement

1. This Order may be cited as the City of Manchester (Off Street Parking Places) (Manchester City Centre) (Amendment) Order 2001 and shall come into operation on 7th January 2002.

Interpretation

2. In this Order:-
 - (1) The Interpretation Act 1978 shall apply for the interpretation of this Act as it applies for the interpretation of an Act of Parliament
 - (2) "The Order of 1998" means the City of Manchester (Off Street Parking Places) (Manchester City Centre) Order 1998;
 - (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted or as having effect by virtue of any subsequent enactment;
 - (4) Unless the context otherwise requires any expression used in this Order which is also used in the Order of 1998 shall have the same meaning as in that Order.

Amendment of the Order of 1998

3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Order of 1998 shall effect as though:-
 - (a) in Schedule 1 to that Order the parking places specified in Part 1 of Schedule 1 to this Order were deleted therefrom and the parking place specified in Part 2 of Schedule 1 to this Order was included therein
 - (b) in Part 1 of Schedule 2 to that Order the parking place and the charges payable as specified in Schedule 3 to this Order were included therein.
