<u>CITY OF MANCHESTER (ADDINGTON STREET AND ADJACENT STREETS</u> <u>MANCHESTER) (PROHIBITION AND RESTRICTION OF WAITING RESTRICTION OF</u> <u>LOADING AND UNLOADING PRESCRIBED ROUTES PROHIBITION OF U-TURNS AND</u> <u>AMENDMENT) ORDER 1999</u>

The Council of the City of Manchester in exercise of their powers under Sections 1(1), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers and after consultation with the Chief Officer of Police for the County of Greater Manchester in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1.(1) In this Order:-

"disabled person's badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) Regulations 1982;

"disabled person's vehicle" has the same meaning as in The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 1986;

"parking disc" means a disc, issued by a local authority, 125 millimetres square, but coloured orange, and capable of showing the quarter hour period during which a period of waiting begins.

(2) For the purpose of this Order a vehicle shall be regarded as displaying:-

- (a) a disabled person's badge in the relevant position if:-
 - (i) in the case of a vehicle fitted with a dashboard or fascia panel, the badge is exhibited thereon so that Part 1 of the badge is legible from outside the vehicle; or
 - (ii) in the case of a vehicle not fitted with a dashboard or fascia panel, the badge is exhibited in a conspicuous position on the vehicle so that Part 1 of the badge is legible from outside the vehicle
- (b) a parking disc in the relevant position if,
 - (i) in the case of a vehicle fitted with a dashboard or fascia panel, the disc is exhibited thereon so that the quarter-hour period during which the period of waiting began is legible from outside the vehicle; or
 - (ii) in the case of a vehicle not so fitted, the disc is exhibited in a conspicuous position on the vehicle so that the quarter-hour period during which the period of waiting began is legible from outside the vehicle.
- (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Save as provided in Article 3 to this Order every person causing or permitting a vehicle to proceed

PRESCRIBED ROUTE.

- (i) in a north westerly direction on Cable Street shall cause or permit that vehicle on reaching the junction of Cable Street with Rochdale Road to make a left turn into Rochdale Road
- (ii) in a south easterly direction on Kenwright Street shall cause or permit that vehicle on reaching the junction of Kenwright Street with Rochdale Road to make a left turn into Rochdale Road
- (iii) in a south easterly direction on Ludgate Street shall cause or permit that vehicle on reaching the junction of Ludgate Street with Rochdale Road to make a left turn into Rochdale Road
- Nothing in Article 2 of this Order shall apply:-

- a) to any vehicle used for fire brigade purposes or to an ambulance or a vehicle in the service of a police force in any case being used in pursuance of statutory powers; or
- b) to anything done upon the direction or with the permission of a constable in uniform or of a traffic warden
- Save as provided in Article 5 to this Order no person shall cause or permit any vehicle proceeding along:-
 - i) the eastbound carriageway of Rochdale Road to make a U-turn through any of the gaps in the central reservation on the length of Rochdale Road which extends from the junction with Miller Street up to and including the junction with Goulden Street so as to proceed in the opposite direction on the westbound carriageway of Rochdale Road
 - ii) the westbound carriageway of Rochdale Road to make a U-turn through any of the gaps in the central reservation on the length of Rochdale Road which extends from the junction with Goulden Street up to and including the junction with Swan Street so as to proceed in the opposite direction on the eastbound carriageway
 - iii) the eastbound carriageway of Shudehill to make a U-turn at the junction of Miller Street and Swan Street so as to proceed in the opposite direction on the westbound carriageway
 - iv) the southbound carriageway of Miller Street to make a U-turn at the junction with Rochdale Road and Shudehill so as to proceed in the opposite direction on the northbound carriageway
- 5. Nothing in Article 4 of this Order shall apply to any vehicle used for fire brigade purposes or to an ambulance or a vehicle in the service of a police officer or being used in pursuance of statutory powers
- 6. The Greater Manchester County (Various Roads Manchester) (Prohibition and Restrictions of

Waiting and One Way) (One Way) (No 1) (County) Order 1974 shall have effect as though:-

- (i) In Schedule 1 to that Order the sides of lengths of road specified in:-
 - (a) Part 1 of the Schedule to this Order were deleted therefrom and the sides of lengths or road specified in Part 2 of the Schedule to this Order were substituted therefor
 - (b) Part 3 of the Schedule to this Order were included therein
- (ii) In Schedule 2 to that Order the sides of lengths of road specified in Part 4 of the Schedule to this Order were deleted therefrom and the sides of lengths of road specified in Part 5 of the Schedule to this Order were substituted therefor
- (iii) In Schedule 3 to that Order the sides of lengths or road specified in Part 6 of the Schedule to this Order were included therein
- (iv) In Schedule 4 to that Order the sides of lengths of road specified in Part 7 of the Schedule to this Order were deleted therefrom
- (v) After the words "Schedule 6 to this Order" in the second paragraph of Article 6 of that Order there were inserted the words set out in Part 8 of the Schedule to this Order and there be added to that Order the further Schedule specified in Part 9 of the Schedule to this Order
- (vi) In Schedule 5 to that Order the length of road specified in Part 10 of the Schedule to this Order were deleted therefrom and the sides of lengths or road specified in Part 11 of the Schedule to this Order were substituted therefor
- (7) Nothing in this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on the sides of length of road specified in Schedules 1, 2 and 3 to the Greater Manchester County (Various Roads Manchester) (Prohibition and Restriction of Waiting and One-Way) (No 1) (County) Order 1974 (as amended) (the 1974 Order) for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle on the same side of length of road on the same day). Provided in relation to the lengths of road specified in Schedule 3 to the 1974 Order that such period lies entirely outside the periods during which the prohibition on loading and unloading specified in Schedule 4 to the 1974 Order (as amended) applies
- 8. This Order shall come into operation on 6th December 1999 and may be cited as the City of Manchester (Addington Street and Adjacent Streets Manchester) (Prohibition and Restriction of Waiting Restriction of Loading and Unloading Prescribed Routes Prohibition of U-turns and Amendment) Order 1999.


