

**CITY OF MANCHESTER (CHINA LANE, MANCHESTER CITY CENTRE)**  
**(PROHIBITION OF DRIVING EXCEPT FOR CYCLES) ORDER 2005**

The Council of the City of Manchester in exercise of their powers under Sections 1(1) and (2) and 2(1) to (3) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police for the County of Greater Manchester in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Interpretation

1. (1) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- (2) "cycle" has the same meaning as in Section 192(1) of the Road Traffic Act 1988

Prohibition of Driving

2. Save as provided in Article 3 to this Order no person shall, except upon the direction or with the permission of a constable in uniform or of a traffic warden, cause or permit any vehicle except for a cycle to enter, proceed or wait in the length of road specified in the Schedule to this Order.

Exemptions

3. Nothing in Article 2 to this Order shall prevent any person causing or permitting any vehicle to enter, proceed or wait in the length of road specified in the Schedule to this Order so far as such entry or proceeding is reasonably necessary to enable to vehicle to be used for any of the following purposes:-
  - (a) police, fire brigade or ambulance purposes or any vehicle being used in pursuance of statutory powers or duties;
  - (b) in the service of any local authority or water undertaking in pursuance of statutory powers or duties;
  - (c) the maintenance, cleansing, improvement or reconstruction of the length of road or the laying, erection, alteration or repair in or adjacent to the said length of road, or any sewer, or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in the Telecommunications Act 1984;
  - (d) any demolition or building operation.

Commencement

4. This Order shall come into operation on 17<sup>th</sup> May 2005 and may be cited as the City of Manchester (China Lane, Manchester City Centre) (Prohibition of Driving Except for Cycles) Order 2005.

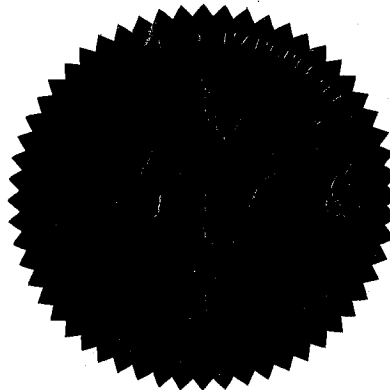
