- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 2. The Order of 2004 is hereby amended by:-
 - (a) the deletion of the lengths of road specified in Column 2 of Schedule 1 to this Order from the Schedule to the Order of 2004 as specified in Column 1 of Schedule 1 to this Order;
 - (b) the inclusion of the lengths of road as specified in Column 3 of Schedule 1 in the Schedule to the Order of 2004 as specified in Column 1 of Schedule 1 to this Order.
- 3. The Order of 2004 is hereby amended by: -
 - (a) the deletion of the parking places specified in Part 1 of Schedule 2 to this Order;
 - (b) the inclusion of the parking places as specified in Part 2 of Schedule 2 to this Order.
- 4. This Order shall come into operation on 6th May 2005 and may be cited as the City of Manchester (Controlled Parking Zone) (Manchester City Centre) (No.14) Amendment No. 2 Order 2005




