## CITY OF MANCHESTER (CONTROLLED PARKING ZONE) (MANCHESTER CITY CENTRE) (NO. 21) AMENDMENT NO. 3 ORDER 2005

The Council of the City of Manchester in exercise of their powers under Sections 1, 2, 3, 4, 32, 35, 45, 46, 49, 51 and 53 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police for the County of Greater Manchester in Accordance with Part III of Schedule 9 to the Act, hereby make the following Order: -

- 1. In this Order: -
  - "the Order of 2003" means the City of Manchester (Controlled Parking Zone) (Manchester City Centre) (No. 21) Order 2003;
  - (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 2. The Order of 2003 is hereby amended by: -
  - (a) the deletion of the length of road specified in Schedule 1 to this Order from Schedules 1 and 3 of the Order of 2003;
  - (b) the inclusion of the lengths of road specified in Schedule 2 to this Order in Schedules 1 and 3 of the Order of 2003;
  - (c) the inclusion of the Goods Vehicle Loading Bay specified in Schedule 3 to this Order in Schedule 12 of the Order of 2003.
- 3. This Order shall come into operation on 3<sup>rd</sup> October 2005 and may be cited as the City of Manchester (Controlled Parking Zone) (No. 21) (Manchester City Centre) Amendment No. 3 Order 2005


