CITY OF MANCHESTER (HARDSHAW CLOSE, HARTFIELD CLOSE, RUDCROFT CLOSE, SEFTON CLOSE AND WHITEKIRK CLOSE, ARDWICK) (OFF STREET PARKING PLACES) ORDER 2005

The Council of the City of Manchester in exercise of the powers conferred on it by Sections 32, and 35(1) to (3) of the Road Traffic Regulation Act 1984 and of all other enabling powers and after consultation with the Chief Constable of Greater Manchester Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

CITATION AND COMMENCEMENT

1. This Order may be cited as the City Of Manchester (Hardshaw Close, Hartfield Close, Rudcroft Close, Sefton Close and Whitekirk Close, Ardwick) (Off Street Parking Places) Order 2005 and shall come into operation on 11 October 2005.

INTERPRETATION

2. (i) In this Order the following expressions have the meanings hereby assigned to them:-

"the Act" means the Road Traffic Regulation Act 1984;

"chargeable hours" means the hours specified in Column 2 of Schedule 2 to this Order;

"the Council" means the Council of the City of Manchester;

"disabled person's badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000;

"disabled person's vehicle" has the same meaning as in the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;

"driver" in relation to a vehicle left at or waiting in a parking place means the person driving the vehicle at the time it was left at or is waiting at the parking place.

"dual purpose vehicle" means a vehicle constructed or adapted for the carriage both of passengers and of goods or burden of any description being a vehicle of which the unladen weight does not exceed 2 tonnes.

"dwellinghouse" means a dwellinghouse or part of a dwellinghouse used for residential occupation.

"goods vehicle" means a motor vehicle constructed or adapted for use for the carriage of goods or burden of any description or a trailer so constructed or adapted.

"invalid carriage" has the same meaning as in Section 136 of the Act.

"motor car" means a mechanically propelled vehicle constructed or adapted to carry not more than seven passengers exclusive of the driver, or any other vehicle the weight of which unladen does not exceed three tonnes and a half:

"motor cycle" means a mechanically propelled vehicle (not being an invalid carriage) with fewer than four wheels of which the weight unladen does not exceed 410kg and not having a sidecar attached;

"parking attendant" means a person authorised by or on behalf of the Council to supervise any parking place;

"parking bay" means a space in a parking place which is provided for the leaving of a vehicle and which is marked in the manner specified in Article 5 of this Order;

"parking charge" means the amounts specified in Column 4 of Schedule 2 to this Order;

"parking place" means any area of land specified in Columns 1 and 2 of Schedule 1 to this Order for use as a parking place and within which parking bays may be indicated;

"parking ticket" means a ticket or consecutively numbered tickets issued by a parking ticket machine pursuant to this Order and indicating the payment of a parking charge and the period for which the parking charge has been paid;

"parking ticket machine" means an apparatus designed to display the time externally, to accept payment by drivers and to issue parking tickets indicating the payment of a parking charge and the date and parking period in respect of which it has been paid;

"passenger vehicle" means a motor vehicle (other than a motor cycle or invalid carriage) constructed solely for the carriage of passengers and their effects and adapted to carry not more than 12 passengers exclusive of the driver and not drawing a trailer.

"pedal cycle" means a unicycle, bicycle or tricycle or cycle having four or more wheels not being in any case mechanically propelled unless it is an electrically assisted pedal cycle of such class as is to be treated as not being a motor vehicle for the purposes of the Act;

"permit holder" means the person to whom a residents' parking permit has been issued under the provisions of this Order.

"principal place of residence" means a place where the applicant for a residents' parking permit stays overnight for at least four nights per week during a period of at least 10 months per year.

"registered keeper" is the person for the time being registered with the Driving and Vehicle Licensing Agency as the person recorded as keeping the vehicle and the person named on the Vehicle Registration Document. The registered keeper is not necessarily either the legal owner of the vehicle or the driver or user of the vehicle for the time being.

"relevant position" has the same meaning as in the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;

"residents' parking permit" means a parking permit issued by the Council pursuant to Article 13 of this Order.

"trailer" means a vehicle other than a motor vehicle.

"value card" means any credit or debit card either purchased from the Council or from a third party whose involvement has been approved by the Council for use instead of coins in a parking ticket machine;

"vehicle" unless the context otherwise requires means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along roads whether by animal or mechanical power;

(ii) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

REFERENCES TO ARTICLES AND SCHEDULES

3. Any reference in this Order to a numbered Article or Schedule is a reference to the Article in or Schedule to this Order bearing that number.

DESIGNATION OF PARKING PLACES

4. Each area of land which is described in Schedule 1 to this Order may be used subject to the provisions of this Order as a parking place for vehicles.

LAYING OUT AND MARKING OF PARKING PLACES AND PARKING BAYS

5. The limits of each parking place and the limits of every parking bay in that parking place shall be indicated in such manner as the Council may determine by lines, study or other indications.

VEHICLES WHICH MAY USE PARKING PLACES

6. Each parking place may be used, subject to the provisions of this Order for the leaving of vehicles of such classes as are specified in relation to that parking place in Column 3 of Schedule 1 to this Order.

RESTRICTION OF USE OF PARKING PLACES

- 7. (i) Subject to Article 7(iii) and to the exceptions set out in Article 33 no person shall leave a vehicle at a parking place during the chargeable hours for a period exceeding 3 hours;
 - (ii) Subject to the exceptions set out in Article 33 where a vehicle has been left at a parking place during the chargeable hours and is then taken away from that parking place the vehicle shall not be left at that parking place again until one hour has elapsed from the time at which the vehicle was taken away from that parking place or the permitted hours have expired whichever is the earlier:
 - (iii) The restrictions as to the maximum length of time for which a vehicle may be left in a parking place as specified in Article 7 (i) and the restrictions on returning to a parking place specified in Article 7 (ii) shall not apply to:-
 - (a) disabled person's vehicles on which there is displayed a valid disabled person's badge in the relevant position; or
 - (b) vehicles on which there is displayed a residents' parking permit in accordance with Article 12 (iv) authorising that vehicle to park at the parking place at which the vehicle has been left;
 - (iv) No person shall except with the permission of a person authorised by the Council in that behalf drive or permit to be driven any vehicle in a parking place for any purpose other than the purpose of leaving that vehicle in the parking place in accordance with the provisions of this Order or for the purpose of departing from the parking place;
 - (v) No person shall use any vehicle while it is in a parking place in connection with the sale of any article to any person in or near the parking place or in connection with the selling or offering for sale or hire of his skill in handicraft or his services in any other capacity other than with the written consent of the Council without prejudice to any planning or health regulations which may require to be met;
 - (vi) No person shall, wash, clean or overhaul any vehicle or execute any mechanical or other alterations or repairs to the vehicle while it is in a parking place except such repairs as may be essential for the purpose of enabling the vehicle to be towed or driven away from the parking place;
 - (vii) No person shall use any part of a parking place or any vehicle left in a parking place for sleeping, camping or cooking;
 - (viii) The driver of a vehicle using a parking place shall stop the engine as soon as the vehicle is in position in the parking place and shall not start the engine except when about to change the position of the vehicle in or to depart from the parking place;

- (ix) The driver of a vehicle using a parking place shall not sound any horn or similar instrument except for the avoidance of danger when about to change the position of a vehicle in or depart from the parking place;
- (x) Where, within a parking place, there is a sign or surface marking which indicates that a parking bay is available only for a disabled person's vehicle the driver of a vehicle shall not permit the vehicle to wait in the parking bay unless it is a disabled person's vehicle which is carrying the disabled person and which displays in the relevant position a valid disabled person's badge;
- (xi) Where in a parking place signs have been erected or surface markings laid for the purpose of indicating the entrance to or exit from the parking place or indicating that a vehicle using the parking place shall proceed in a specified direction within the parking place no person shall drive or permit to be driven any vehicle so that it enters the parking place otherwise than by an entrance, leaves the parking place otherwise than by an exit or proceeds in a direction contrary to that specified;
- (xii) Where at or near the entrance to a parking place there is a sign or surface marking which indicates that the parking place is available only to vehicles under a specified height, width, length or weight or only at certain times no person shall cause or permit to enter the parking place any vehicle which exceeds that height, width, length or weight or outside those times;

AMOUNT OF PARKING CHARGE AT PARKING PLACES

8. Except as provided in Article 12, the parking charge for a vehicle left in any parking place during the chargeable hours shall be in accordance with the parking charges specified in Schedule 2 to this Order.

PAYMENT OF PARKING CHARGE

- 9. (i) Except as provided in Articles 12 and 34, on arrival at the parking place a parking ticket shall be purchased by the insertion in a parking ticket machine within or in the vicinity of the parking place of a coin or coins of a denomination accepted by the parking ticket machine to the value of the parking charge or by the use of an appropriate value card.
 - (ii) The parking ticket issued by the parking ticket machine shall then be displayed on the vehicle in respect of which it has been issued at all times during which the vehicle is left in the parking place during the chargeable hours on the front of the vehicle so that all the particulars on that side of the parking ticket which bears the indication that a parking charge has been paid are readily visible to a person standing beside the vehicle.

INDICATIONS BY PARKING TICKET MACHINES

10. (i) Payment of the parking charge for a vehicle left in a parking place shall be indicated by the issue from a parking ticket machine associated with the parking place in which the vehicle was left of a numbered ticket having a mark which enables the issuing parking ticket machine to be identified and indicating what parking charge has been paid and either the day and time of

- payment or the day and time of expiry of the validity of the parking ticket and by the display of the parking ticket on the vehicle in the manner specified in Article 9;
- (ii) Where the parking ticket indicates the day and time of expiry of the parking ticket the period for which the parking charge has been paid shall be deemed to have expired when the time shown on the clock on the parking ticket machine which issued the parking ticket is later than the time shown on the ticket:
- (iii) Where the parking ticket indicates the day and time of payment the period for which the parking charge has been paid shall be deemed to have expired when the time shown on the clock on the machine which issued the parking ticket exceeds the time of payment plus the time paid for.

INDICATIONS BY PARKING TICKET MACHINES AS EVIDENCE

- 11. (i) If at any time while a vehicle is left in a parking place no parking ticket is displayed on that vehicle in accordance with the provisions of Article 9, it shall be presumed unless the contrary is proved that the parking charge has not been duly paid;
 - (ii) If at any time while a vehicle is left in a parking place the clock on a parking ticket machine associated with the parking place in which the vehicle is left and the parking ticket displayed on the vehicle and issued from the relevant parking ticket machine indicate that the period for which the parking charge has been paid has expired in the circumstances referred to in paragraphs (ii) or (iii) of Article 10 it shall be presumed unless the contrary is proved that the parking charge has been duly paid and that the period for which payment was made by the parking charge has already expired.

EXEMPTIONS FROM PARKING CHARGE

- 12. (i) Any disabled person's vehicle left in a parking place which displays in the relevant position a valid disabled person's badge shall be exempt from the parking charge;
 - (ii) Without prejudice to paragraph (i) of this Article a vehicle to which paragraph (i) applies shall use the parking place in accordance with all other provisions of this Order;
 - (iii) Any solo motor cycle or pedal cycle left in a part of a parking place at which the Council has placed a sign or signs indicating that part of the parking place is for the use of the said cycles shall be exempt from the parking charge;
 - (iv) Any vehicle left in a parking place which displays in the position hereinafter provided a residents' parking permit issued by the Council in accordance with the provisions of this Order for use in that parking place at that time shall be exempt from the parking charge:-
 - (a) in the case of a vehicle fitted with a front windscreen on the near side

thereon and immediately behind the windscreen and with its front facing forward; or

- (b) in the case of a two wheeled motorcycle in a conspicuous position on the vehicle in front of the driving seat;
- (c) in the case of any other vehicle not fitted with a front windscreen, in a conspicuous position on the vehicle.

The residents' parking permit shall be so displayed on the vehicle that the details shown on the front are clearly visible to a person standing beside the vehicle.

RESIDENTS' PARKING PERMITS

- 13. The Council may issue a residents' parking permit permitting a specified vehicle to park during the chargeable hours in parking places specified by the Council to an applicant who satisfies the Council that he:-
 - (i) (a) uses as his principal place of residence a dwellinghouse located at; or
 - (b) is a minister of religion in whose parish is located; or
 - a postal address listed in Schedule 3 to this Order.
 - (ii) has no suitable parking facility within a reasonable distance of such premises; and
 - (iii) is the owner of a motor car, a passenger vehicle, a dual purpose vehicle, a goods vehicle, an invalid carriage or a motor cycle or if he is not the owner of such a vehicle that he has the permission of the owner of such vehicle to use such a vehicle from the premises referred to in Article 13 (i).

APPLICATION AND ISSUE OF RESIDENTS' PARKING PERMITS

- 14. An application for a residents' parking permit shall be made in writing to the Council on the form issued by and obtainable from the Council and shall include all particulars and information required by such form.
- 15. The Council may require an applicant for a residents' parking permit to produce to an officer of the Council such evidence in respect of the application as may be reasonably necessary to verify the particulars or information given to him by the applicant.
- 16. Residents' parking permits shall be issued by the Council by ordinary post upon the Council being satisfied that the applicant for such a permit has satisfied the criteria set out in this Order for the issue of such permits.
- 17. Should a residents' parking permit be lost, damaged or defaced the Council will, subject to any charge it considers appropriate, issue a duplicate permit.

FORM OF RESIDENTS' PARKING PERMITS

- 18. A residents' parking permit issued under the provisions of this Order shall be in writing and shall include the following particulars:-
 - (i) The registration mark of the vehicle in respect of which the residents' parking permit has been issued.
 - (ii) The period during which the residents' parking permit has been granted and/or the date on which the residents' parking permit is due to expire, subject to the provisions of this Order as to termination of residents' parking permits.
 - (iii) An authentication that the residents' parking permit has been issued by the Council.

DUPLICATE RESIDENTS' PARKING PERMITS

- 19. If a residents' parking permit issued under the provisions of this Order is mutilated or defaced or the figures or particulars on it have become illegible or the colour of the residents' parking permit has become altered by fading or otherwise, the permit holder shall surrender it to the Council and may then apply to the Council for the issue to him of a duplicate residents' parking permit.
- 20. If a residents' parking permit is lost or destroyed, the permit holder may apply to the Council for the issue to him of a duplicate residents' parking permit.
- 21. Any duplicate residents' parking permit issued under the provisions of Articles 19 or 20 shall be marked as a duplicate, and upon the issue of a duplicate residents' parking permit the original residents' parking permit which it duplicates shall become invalid.
- 22. The provisions of this Order relating to applications for residents' parking permits and residents' parking permits generally shall apply to applications for duplicate residents' parking permits and duplicate residents' parking permits generally.

TERMINATION OF RESIDENTS' PARKING PARKING PERMITS

- 23. A residents' parking permit issued under the provisions of this Order shall terminate and cease to be valid:-
 - (i) immediately upon surrender of such permit to the Council;
 - (ii) immediately without notice upon the expiry of the period specified in such permit; or
 - (iii) on a date specified in a notice addressed to the holder of the residents' parking permit revoking the residents' parking permit on the grounds that any or all of the matters as to which the Council was satisfied when granting the residents' parking permit is or are no longer satisfied or for any other reason

whatsoever.

24. Any notice addressed to the holder of the residents' parking permit under the provisions of Article 23 shall be sufficiently served if addressed to that person and delivered to him personally or sent by ordinary post to his last known residence or place of business.

REMOVAL OF RESIDENTS' PARKING PERMITS AND DISABLED PERSON'S BADGES

Where a residents' parking permit or disabled person's badge has been displayed on a vehicle in accordance with the provisions of this Order no person shall remove such permit or badge from display on such vehicle unless expressly authorised to do so by the driver of the vehicle.

MANNER OF STANDING IN PARKING PLACES

26. Each vehicle left in a parking place shall stand so that every part of the vehicle is within the limits of a parking bay, provided that in the case of any parking place where the length of any vehicle precludes it from standing wholly within the limits of a parking bay, that vehicle shall so stand in the parking bay that as much of the vehicle as possible is within the limits of the parking bay and that such portion as is beyond the limits of the parking bay does not constitute a danger or obstruction to other users of the parking place.

ALTERATION OF POSITION OF VEHICLE IN PARKING PLACES

Where any vehicle is standing in a parking place in contravention of the provisions of Article 26 a parking attendant or any other person authorised by the Council may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions and may recover any expenses associated with this alteration.

REMOVAL OF VEHICLES FROM PARKING PLACES

28. Where a parking attendant or any other person authorised by the Council is of the opinion that any of the provisions contained in this Order have been contravened he may remove or cause to be removed the vehicle from the parking place and where it is so removed shall provide for the safe custody of the vehicle. The Council may then recover all expenses associated with the removal and may retain possession of the vehicle until all monies due to the Council in respect of the vehicle have been duly paid (as determined by Section 102 of the Act).

MOVEMENT OF VEHICLES IN PARKING PLACES IN EMERGENCIES

29. A parking attendant or any person authorised by the Council may in the case of an emergency move, remove or cause to be moved or removed to any place he thinks fit, vehicles left in a parking place.

METHOD OF MOVEMENT OR REMOVAL

Any person altering or causing the alteration of the position of a vehicle by virtue of Article 27 or removing or causing the removal of a vehicle by virtue of Articles 28 and 29 may do so by towing or driving the vehicle or by such other manner as he may think is reasonably necessary to enable the position of the vehicle to be altered or the vehicle to be removed.

POWER TO SUSPEND PARKING PLACES

- 31. (i) Any person duly authorised by the Council may suspend the use of a parking place or any part thereof whenever such suspension is considered reasonably necessary;
 - (ii) On any suspension of a parking bay in a parking place in accordance with the provisions of the preceding paragraph any person duly authorised by the Council may use suitable means to indicate that the use of the parking bay or parking place is suspended;
 - (iii) No person shall cause or permit any vehicle to wait in any part of a parking place which has been suspended in accordance with the provisions of this Article except with the permission of a person authorised by the Council.

POWER TO DISPOSE OF ABANDONED VEHICLES

32. The Council may in respect of a vehicle which has been removed from a parking place in pursuance of Articles 28 and 29 if it appears to them to have been abandoned, sell or otherwise dispose of the vehicle after having made reasonable enquiry to ascertain the name and address of the owner of the vehicle.

<u>CIRCUMSTANCES IN WHICH WAITING OF VEHICLES IN PARKING PLACES IS PERMISSIBLE</u>

- Without prejudice to the foregoing provisions of this Order any vehicle may wait during the chargeable hours in a parking place or part of a parking place (other than a parking place or part of a parking place the use of which has been suspended) if:-
 - (i) the vehicle is waiting only for so long as is necessary to enable a person to board or alight from the vehicle; or
 - (ii) the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid an accident; or
 - (iii) the vehicle is a vehicle used for fire brigade purposes or an ambulance, or a vehicle (other than a passenger vehicle) in the service of a local authority or a vehicle in the service of a police force in either case being used in pursuance of statutory powers or duties; or
 - (iv) the vehicle is waiting only for so long as may be necessary to enable it to be used in connection with the removal of any obstruction to traffic; or

- (v) the vehicle is in the service of or employed by the Post Office or any telecommunications operator and is waiting while postal packets addressed to premises adjacent to the parking place in which the vehicle is waiting are being unloaded from the vehicle, or, having been unloaded therefrom, are being delivered or while postal packets are being collected from premises or posting boxes adjacent to the parking place in which the vehicle is waiting, or is in use in connection with the servicing of telephone kiosks adjacent to the parking place.
- 34. The driver shall not be liable to pay or display a parking charge or hold or display a valid residents' parking permit while waiting in a parking place in accordance with Article 33.
- 35. The restrictions as to the maximum length of time for which a vehicle may be left in a parking place as specified in Article 7 (i) and the restrictions on returning to a parking place specified in Article 7 (ii) shall not apply to vehicles waiting in a parking place in accordance with Article 33.
- 36. Nothing in Articles 33, 34 and 35 shall be taken as authorising anything which would be a contravention of any Regulations made or having effect as if made under Section 25 of the Act.
- 37. Except as permitted by the foregoing provisions of this Order, the driver of a vehicle shall not cause or permit the vehicle to wait in a parking place during the chargeable hours.

MANNER OF WAITING IN PARKING PLACES

38. A person causing or permitting a vehicle to wait in a parking place by virtue of the provisions of Article 33 shall take all such steps as are necessary to ensure that every part of the vehicle is within the limits of a parking bay, provided that in the case of any parking place where the length of any vehicle precludes it from standing wholly within the limits of a parking bay, that as much of the vehicle as possible is within the limits of the parking bay and that such portion as is beyond the limits of the parking bay does not constitute a danger or obstruction to other users of the parking place.

RESPONSIBILITY OF DRIVER

39. The person who was driving the vehicle at the time when it was left in the parking place shall be responsible for complying with the provisions of all relevant Articles of this Order and unless proved to the contrary the registered keeper of the vehicle shall be deemed to be the driver of that vehicle.

DISCLAIMER

40. The Council shall not be held liable for any damage to loss of or theft of and/or from any vehicle in any parking place.
