

## ROAD TRAFFIC REGULATION ACT 1984 - SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of waiting restrictions in the area surrounding the Sportcity Stadium Complex, Manchester on event days, hereby:-

- 1. authorises the erection at or within 5 metres of the sites marked with a green cross on the attached schedule of plans numbered GT46/2/142(Pt1)-3 and a blue cross on the attached schedule of plans numbered GT46/2/142(Pt2)-1 of a traffic sign (hereinafter referred to as "the authorised sign A") conforming as to size, colour and character with that shown at A in the attached schedule of drawings numbered GT46/2/142(Pt2)-3, save that (a) the name of the zone may be varied and (b) the times of the day, day of the week, date and month may be varied as appropriate; and
- 2. authorises the erection at or within 5 metres of the sites marked with an orange cross on the said schedule of plans numbered GT46/2/142(Pt1)-3 and a green cross on the said schedule of plans numbered GT46/2/142(Pt2)-1 of a traffic sign (hereinafter referred to as "the authorised sign B") conforming as to size, colour and character with that shown at B in the said schedule of drawings, save that (a) the name of the zone may be varied and (b) the times of the day, day of the week, date and month may be varied as appropriate; and



- 3. authorises the erection within the outlined zone areas on the said schedules of plans of a traffic sign (hereinafter referred to as "the authorised sign C") conforming as to size, colour and character with that shown at C in the said schedule of drawings, save that the name of the zone may be varied as appropriate; and
- 4. directs that the authorised sign C shall be erected in sufficient numbers to give adequate information to road users of the waiting restrictions in force in the said outlined zone areas; and
- 5. directs that the road markings shown in diagrams 1017, 1018.1, 1028.3, 1028.4, 1032 and 1033 in Schedule 6 to the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations") need not be used in the said outlined zone areas; and
- 6. directs that it is a condition of this authorisation that the authorised signs A, B and C shall be erected only to indicate the effect of a corresponding Traffic Regulation Order; and
- 7. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A, B and C at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs A, B and C and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.



The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign A in the same manner as they apply to the sign shown in diagram 663 in Schedule 2 to those Regulations.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised signs B and C in the same manner as they apply to the sign shown in diagram 660 in Schedule 2 to those Regulations.

The provisions of Direction 42 of the Traffic Signs General Directions 2002 (Part II of SI 2002/3113) shall apply to the authorised signs A and B in the same manner as they apply to the sign shown in diagram 663 in Schedule 2 to the 2002 Regulations.

This authorisation replaces the earlier ones dated 15 July 2003 and 10 September 2004 under reference GT46/2/142 which are hereby revoked.


