CITY OF MANCHESTER (CONTROLLED PARKING ZONE)
(MANCHESTER CITY CENTRE) (NO.8) AMENDMENT (No. 5) ORDER 2011

The Council of the City of Manchester in exercise of their powers under Sections 1, 2, 3, 4, 32, 35, 45, 46, 49, 51 and 53 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police for the County of Greater Manchester in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. In this Order:-

- (1) "2005 Order " means the City of Manchester (Controlled Parking Zone) (Manchester City Centre) (No.1) Order 2005 dated 28 February 2005;
- (2) "2006 Order" means the City of Manchester (Controlled Parking Zone) (Manchester City Centre) Residents Amendment (No. 1) Order dated 5 April 2006;
- (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

ARRANGEMENT OF 2005 ORDER - SCHEDULES

2. The following amendments will be made to the index on page 4 setting out the Schedules to the 2005 Order:-

2.1 Where it reads;

' SCHEDULE 2 No Waiting – Monday to Saturday 8.00am – 6.00pm'

will be deleted and replaced with:

'SCHEDULE 2 No Waiting – Monday to Sunday 8.00am – 8.00pm'

2.2 Where it reads:

'SCHEDULE 5 2 hours – Monday to Saturday 8.00am – 6.00pm'

will be deleted and replaced with:

'SCHEDULE 5 2 hours – Monday to Sunday 8.00am – 8.00pm'

2.3 Where it reads:

**'SCHEDULE 9 Goods Vehicles Loading/Unloading Parking Places
Monday to Saturday 8.00am – 6.00pm
Maximum Stay 15 minutes'**

will be deleted and replaced with:

**'SCHEDULE 9 Goods Vehicles Loading/Unloading Parking Places
Monday to Sunday 8.00am – 8.00pm
Maximum Stay 15 minutes'**

2.4 At the end of the index, insert the following:

2005 ORDER - PART 1 PRELIMINARY – Interpretation

3. The following definitions in the 2005 Order:

“permitted hours’ means:-

in relation to a parking place specified in Schedule 5 to this Order the period between 8.00am and 6.00pm on Mondays to Saturday inclusive any such day not being Christmas Day, Good Friday or any other Bank Holiday;

“ restricted hours’ means:-

(i) in relation to any restricted road specified in Schedule 1 to this Order the whole 24 hours of every day and

(ii) in relation to any restricted road specified in Schedule 2 but excluding any side of length of road specified in Schedule 1 to this Order the period between 8.00am and 6.00pm on Mondays to Saturdays inclusive;

“loading parking place” means the areas of road specified in Column 1 of

Schedules 8 and 9 to this Order to be used as a parking place for the purpose of loading and unloading of goods and unless otherwise so specified bounded on one side by the edge of the carriageway and on the other side by a road marking complying with Diagram 1028.3 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002;

will be deleted and replaced with the following definitions:-

“ permitted hours’ means:-

in relation to a parking place specified in Schedule 5 to this Order the period between 8.00am and 8.00pm on Mondays to Sundays inclusive any such day not being Christmas Day, Good Friday or any other Bank Holiday .’

“ restricted hours’ means:-

(i) in relation to any restricted road specified in Schedule 1 to this Order the whole 24 hours of every day ,and

(ii) in relation to any restricted road specified in Schedule 2 to this Order but

excluding any side of length of road specified in Schedules 1 and 11 to this Order the period between 8.00am and 8.00pm on Mondays to Sundays inclusive, and

(iii) in relation to any restricted road specified in Schedule 11 to this Order but excluding any side of length of road specified in Schedules 1 and 2 to this Order the period between 8.00am – 6.00pm on Mondays to Sundays inclusive

“loading parking place” means the areas of road specified in Column 1 of Schedules 8, 9 and 12 to this Order to be used as a parking place for the purpose of loading and unloading of goods and unless otherwise so specified bounded on one side by the edge of the carriageway and on the other side by a road marking complying with Diagram 1028.3 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002;

AMOUNT AND METHOD OF PAYMENT OF PARKING CHARGE FOR TICKET PARKING PLACES

4. In Article 6 of the 2005 Order the table setting out the charges payable for 2 Hour Parking Places shall be deleted and replaced with the following new table of charges, as set out below:

Parking Charge	Parking Period
£1.35	Up to 30 minutes
£2.70	Up to 1 hour
£4.00	Up to 1 hour 30 minutes
£5.40	Up to 2 hours

PAYMENT OF PARKING CHARGE AT TICKET PARKING PLACE

5. Article 7 of the 2005 Order as amended and replaced by the 2006 Order shall be deleted in its entirety and replaced with the following:-

“ **PAYMENT OF PARKING CHARGE AT TICKET PARKING PLACES**

7. Save as provided in this Order during the permitted hours no person shall leave any vehicle in a parking place specified in this Order without having paid the parking charge in respect of the parking period for which the vehicle has been left and

a) in the case of ticket parking place without having displayed a ticket issued by a ticket parking meter in accordance with the provisions of Article 8 of this Order; or

b) without displaying in the relevant position either

- (i) a valid resident's parking permit for the permit zone in which the parking place is situated between the hours of 8.00am and 9.00am and 5.00pm and 8.00pm on Monday to Friday or between the hours of 8.00am and 8.00pm on Saturday and Sunday, or
(ii) a valid resident's parking permit together with a valid convenience ticket for the permit zone in which that parking place

is situated between the hours of 9.00am and 1.00pm and 1.00pm and 5.00pm on Monday to Friday

Provided that for the purposes of this Article if a vehicle when first placed in a ticket parking place is exempt from payment of any charge by virtue of the provisions of Article 19 of this Order and continues to wait in that parking place otherwise than in accordance with those provisions the parking charge shall be treated as having been incurred and to be payable at that time when the vehicle ceased to wait by virtue of those provisions and all the provisions of this Order shall then apply accordingly."

NO TICKET OR ADDITIONAL COINS TO BE INSERTED AFTER PAYMENT OF THE PARKING CHARGE

6. Article 11 (3) of the 2005 Order is hereby deleted.

APPLICATION FOR ISSUE OF AND USE OF PERMITS

7. Article 22A of the 2005 Order as inserted by the 2006 Order shall be deleted and replaced with the following:-

"22A Any resident who satisfies the Council that:

- a) his principal place of residence is located within the list of streets specified in Schedule A to this Order
- b) that the building within which the principal place of residence is located has no off-street parking facility
- c) he holds a valid driving licence and is the owner of a permitted vehicle
- d) that he uses as his principal place of residence a dwelling house which first came into such use before 31 December 2004

may apply for the issue of a resident's parking permit in accordance with Article 22D to this Order for the parking of that vehicle in a parking place specified in Schedule B to this Order between the hours of 8.00am and 9.00am and between the hours of 5.00pm and 8.00pm on Monday to Friday and between the hours of 8.00am and 8.00pm on Saturday and Sunday;

and any such application shall include such particulars and such information together with the appropriate payment as is required by the Council."

8. Article 22D of the 2005 Order as inserted by the 2006 Order shall be deleted and replaced with the following:-

"22D For the purposes of Article 22A of this Order "appropriate payment" means for the issue of a residents parking permit for a maximum quarterly period:

(a) for use in any of the parking places listed in Parts 1, 2 and 3 of Schedule B to this Order the payment of a quarterly sum of £105 (Permit A)

(b) for use in any of the parking places listed in Part 3 of Schedule B to this Order the payment of a quarterly sum £36 (Permit C)

(for the avoidance of doubt, 'quarterly' for the purpose of this Article means one quarter of a calendar year)."

9. Article 22I of the 2005 Order as inserted by the 2006 Order shall be deleted and replaced with the following:-

"22I. At all times during which the vehicle is left in a parking place specified in Schedule B to this Order between the hours of 8.00am and 9.00am and 5.00pm and 8.00pm on Monday to Friday and between the hours of 8.00am and 8.00pm on Saturday and Sunday there shall be displayed on the vehicle in the relevant position a valid resident's parking permit issued in respect of that vehicle so that all the particulars referred to in Article 22H of this Order are readily visible from outside the vehicle."

10. Article 22N of the 2005 Order as inserted by the 2006 Order shall be deleted and replaced with the following:-

"22N For the purposes of Article 22M appropriate payment means:

(a) the payment of the sum of £9.75 per convenience ticket to be used within the twelve month period commencing with the 1st April in any year until the 31st March the following year and which is for use when used in conjunction with a resident's parking permit in any of the parking places specified in Part 1 and Part 2 of Schedule B to this Order;

(b) the payment of the sum of £4.80 per convenience ticket to be used within the twelve month period commencing with the 1st April in any year until the 31st March the following year and which is for use when used in conjunction with a resident's parking permit in any of the parking places specified in Part 3 of Schedule B to this Order.

SCHEDULE 2 - NO WAITING

11. The title to Schedule 2 of the 2005 Order as follows:-

'SCHEDULE 2 No Waiting - Monday to Saturday 8.00am – 6.00pm'

Shall be deleted and replaced with:-

'SCHEDULE 2 No Waiting – Monday to Sunday 8.00am – 8.00pm'

12. The opening paragraph of Schedule 2 of the 2005 Order as follows:-

'Roads or parts of roads in which waiting is restricted between 8.00am and 6.00pm on Monday to Saturday inclusive EXCEPT FOR the roads or parts of road specified in Schedule 1'

Shall be deleted and replaced with:-

'Roads or parts of roads in which waiting is restricted between 8.00am and 8.00pm on Monday to Sunday inclusive EXCEPT FOR the roads or parts of road specified in Schedules 1 and 11'

SCHEDULE 5 PAY & DISPLAY BAYS

13. The opening paragraph of Schedule 5 of the 2005 Order as follows:-

'Ticket Parking Places. Maximum Stay 2 Hours. No return Within 1 Hour Monday - Saturday 8.00am- 6.00pm; Width of parking places 2 metres'

Shall be deleted and replaced with:-

'Ticket Parking Places. Maximum Stay 2 Hours. No return Within 1 Hour Monday - Sunday 8.00am -8.00pm; Width of parking places 2 metres'

14. Days of operation of the parking place in Column 3 of Schedule 5 of the 2005 Order shall be amended by deleting 'Monday to Saturday' where it appears throughout that column and replacing it in each case with 'Monday to Sunday'.

15. Hours of operation of the parking place in Column 4 of Schedule 5 of the 2005 Order shall be amended by deleting '8am – 6pm' where it appears throughout that column and replacing it in each case with '8.00am – 8.00pm'.

SCHEDULE 9 Goods Vehicles Loading/Unloading Parking Places

16. The title to Schedule 9 of the 2005 Order as follows:-

'SCHEDULE 9 Goods Vehicles Loading/Unloading Parking Places Monday to Saturday 8.00am -6.00pm Maximum Stay 15 Minutes.'

Shall be deleted and replaced with:-

'SCHEDULE 9 Goods Vehicles Loading/Unloading Parking Places Monday to Sunday 8.00am – 8.00pm Maximum Stay 15 Minutes'

17. The loading parking place specified in Schedule 1 to this Order is hereby deleted from Schedule 9 to the 2005 Order.

18. 'Days of operation of the loading parking place' in Column 4 of Schedule 9 of the 2005 Order shall be amended by deleting the 'Monday to Saturday' where it appears in that column and replacing it with 'Monday to Sunday'.

19. 'Hours of operation of the loading parking place' in Column 5 of Schedule 9 of the 2005 Order shall be amended by deleting '8am – 6pm' where it appears in that column and replacing it with '8.00am – 8.00pm.'

SCHEDULE B (List of parking places)

20. (i) in Part 1 of Schedule B to the 2005 Order "1 hour maximum stay Pay and Display parking places" shall read as "2 hours maximum stay Pay and Display parking places"
- (ii) in Part 2 of Schedule B to the 2005 Order "For use by Permit A and Permit B residents permit holders" shall read as "For use by Permit A residents permit holders".
- (iii) in Part 3 of Schedule B to the 2005 Order "For use by Permit A Permit B and Permit C residents permit holders" shall read as "For use by Permit A and Permit C residents permit holders".
21. The following Schedules shall be incorporated into the 2005 Order.
This schedules shall be called:

'SCHEDULE 11 No Waiting – Monday to Sunday 8.00am – 6.00pm'

**' SCHEDULE 12 Goods Vehicles Loading/Unloading Parking Places
Monday to Sunday 8.00am – 6.00pm
Maximum stay of 15 minutes'**

The provisions of Schedules 11 and 12 are set out in Schedules 2 and 3 to this Order .

22. This Order shall come into operation on 24th October 2011 and may be cited as the City of Manchester (Controlled Parking Zone) (Manchester City Centre) (No. 8) Amendment (No.5) Order 2011
