

CITY OF MANCHESTER (CONTROLLED PARKING ZONE)
(MANCHESTER CITY CENTRE) (No. 18) AMENDMENT No.8 ORDER 2011

The Council of the City of Manchester in exercise of their powers under Sections 1, 2, 3, 4, 32, 35, 45, 46, 49, 51 and 53 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police for the County of Greater Manchester in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. In this Order:

- (i) "the Order of 2003" means the City of Manchester (Controlled Parking Zone) (Manchester City Centre) (No.18) Order 2003;
- (ii) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

ARRANGEMENT OF THE ORDER OF 2003 – SCHEDULES

2. The index page setting out the Schedules to the Order of 2003 is hereby amended as follows:

- (i) Schedule 2 No Waiting Monday to Saturday 8.00am – 6.00pm shall now read,
- (ii) **Schedule 2 No Waiting Monday to Sunday 8.00am – 8.00pm.**
- (iii) Schedule 5 Ticket Parking Meters 2 hours – Monday to Saturday 8.00am – 6.00pm shall now read,
- (iv) **Schedule 5 Ticket Parking Meters 2 hours – Monday to Sunday 8.00am – 8.00pm.**
- (v) Schedule 12 Goods Vehicles Loading/Unloading Parking Places Monday to Saturday 8.00am – 6.00pm Maximum Stay 15 Minutes shall now read,
- (vi) **Schedule 12 Goods Vehicles Loading/Unloading Parking Places Monday to Sunday 8.00am to 8.00pm Maximum Stay 15 Minutes.**
- (vii) Schedule 13 Ticket Parking Meters 1 hour – Monday to Saturday 8.00am – 6.00pm shall now read,
- (viii) **Schedule 13 Ticket Parking Meters 2 hours – Monday to Sunday 8.00am – 8.00pm.**

(ix) The following Schedules shall be inserted in to the index page to the Order of 2003:

Schedule 14 No Waiting Monday to Sunday 8.00am – 6.00pm.

Schedule 15 Goods Vehicles Loading/Unloading Parking Places Monday to Sunday 8.00am to 6.00pm Maximum stay of 15 minutes

PART 1 PRELIMINARY – INTERPRETATION

3. The following definitions in the Order of 2003 are hereby amended as follows:

(i) 'permitted hours' means:-

in relation to a parking place specified in Schedules 5 and 13 to this Order the period between 8.00am and 6.00pm on Mondays to Saturdays inclusive any such days not being Christmas Day, Good Friday or any other Bank Holiday shall now read,

'permitted hours' means:-

in relation to a parking place specified in Schedules 5 and 13 to this Order the period between 8.00am and 8.00pm on Mondays to Sundays inclusive any such days not being Christmas Day, Good Friday or any other Bank Holiday.

(ii) 'restricted hours' means:-

in relation to any restricted road specified in Schedule 1 to this Order the whole 24 hours of every day and

in relation to any restricted road specified in Schedule 2 but excluding any side of length of road specified in Schedule 1 to this Order the period between 8.00am and 6.00pm on Mondays to Saturdays inclusive shall now read,

'restricted hours' means:-

in relation to any restricted road specified in Schedule 1 to this Order the whole 24 hours of every day;

in relation to any restricted road specified in Schedule 2 to this Order but excluding any side of length of road specified in Schedules 1 and 14 to this Order the period between 8.00am and 8.00pm on Mondays to Sundays inclusive and

in relation to any restricted road specified in Schedule 14 but excluding any side of length of road specified in Schedules 1 and 2 to this Order the period between 8.00am and 6.00pm on Mondays to Sundays inclusive.

(iii) **"loading parking place"** means the areas of road specified in Column 1 of Schedules 11 and 12 to this Order to be used as a parking place for the purpose of loading and unloading of goods and unless otherwise so specified bounded on one side by the edge of the carriageway and on the other side by a road marking complying with Diagram 1028.3 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002; shall now read

"loading parking place" means the areas of road specified in Column 1 of Schedules 11 ,12 and 15 to this Order to be used as a parking place for the purpose of loading and unloading of goods and unless otherwise so specified bounded on one side by the edge of the carriageway and on the other side by a road marking complying with Diagram 1028.3 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002;

PART II DESIGNATION OF TICKET PARKING PLACES

AMOUNT AND METHOD OF PAYMENT OF PARKING CHARGE FOR TICKET PARKING PLACES

4. Article 6 of the Order of 2003 is hereby amended so that the Table setting out the parking charges in relation to the 2 hour parking places shall be deleted and replaced by the Table specified below:

£4.00	Up to 1 hour 30 minutes
£5.40	Up to 2 hours

5. (i) Article 6A of the Order of 2003 are hereby amended so that any reference to 1 hour shall now read 2 hours,
- (ii) Article 6A of the Order of 2003 is hereby amended so that the Table setting out the parking charges in relation to the 2 hour parking places shall be deleted and replaced by the Table specified below:

PAYMENT OF PARKING CHARGE AT TICKET PARKING PLACES

6. Article 7(b)(i) of the Order of 2003 is hereby amended as follows:
- (i) a valid resident's parking permit for the permit zone in which the parking place is situated between the hours of 8.00am and 9.00am and 5.00pm and 6.00pm on Monday to Friday or between the hours of 8.00am and 6.00pm on Saturdays shall now read,
- (ii) a valid resident's parking permit for the permit zone in which the parking place is situated between the hours of 8.00am and 9.00am and 5.00pm and 8.00pm on Monday to Friday or between the hours of 8.00am and 8.00pm on Saturdays and Sundays.

NO TICKET OR ADDITIONAL COINS TO BE INSERTED AFTER PAYMENT OF THE PARKING CHARGE

7. Article 11 (3) of the Order of 2003 is hereby deleted.

APPLICATION FOR ISSUE OF AND USE OF PERMITS

8. Article 22A of the Order of 2003 is hereby amended as follows:

(i) **22A Any resident who satisfies the Council that:**

a) his principal place of residence is located within the list of streets specified in Schedule A to this Order

b) that the building within which the principal place of residence is located has no off street parking facility

c) he holds a valid driving licence and is the owner of a permitted vehicle

d) that he uses as his principal place of residence a dwelling house which first came into such use before 31 December 2004

may apply for the issue of a resident's parking permit in accordance with Article 22D to this Order for the parking of that vehicle in a parking place specified in Schedule B to this Order between the hours of 8.00am and 9.00am and between the hours of 5.00pm and 6.00pm on Monday to Friday and between the hours of 8.00am and 6.00pm on Saturday;

and any such application shall include such particulars and such information together with the appropriate payment as is required by the Council, shall now read,

(ii) **22A Any resident who satisfies the Council that:**

a) his principal place of residence is located within the list of streets specified in Schedule A to this Order

b) that the building within which the principal place of residence is located has no off street parking facility

c) he holds a valid driving licence and is the owner of a permitted vehicle

d) that he uses as his principal place of residence a dwelling house which first came into such use before 31 December 2004

may apply for the issue of a resident's parking permit in accordance with Article 22D to this Order for the parking of that vehicle in a parking place specified in Schedule B to this Order between the hours of 8.00am and 9.00am and between the hours of 5.00pm and 8.00pm on Monday to Friday and between the hours of 8.00am and 8.00pm on Saturday and Sunday;

and any such application shall include such particulars and such information together with the appropriate payment as is required by the Council.

9. Article 22D of the Order of 2003 is hereby amended as follows:

- (i) For the purpose of Article 22A of this Order 'appropriate payment' means for the issue of a residents parking permit for a maximum of period of 12 months commencing with the 1st day of April in any year until 31st March the following year
 - a) for use in any of the parking places listed in Parts 1, 2 and 3 of Schedule B to this Order the payment of the annual sum of £347 (Permit A)
 - b) for use in any of the parking places listed in Parts 2 and 3 of Schedule B to this Order the payment of the annual sum of £198 (Permit B)
 - c) for use in any of the parking places listed in Part 3 of Schedule B to this Order the payment of the annual sum of £116 (Permit C) shall now read,
- (ii) **For the purpose of Article 22A of this Order 'appropriate payment' means for the issue of a residents parking permit for a maximum quarterly period**
 - a) for use in any of the parking places listed in Parts 1, 2 and 3 of Schedule B to this Order the payment of a quarterly sum of £105 (Permit A)
 - b) for use in any of the parking places listed in Part 3 of Schedule B to this Order the payment of a quarterly sum of £36 (Permit C)

(for the avoidance of doubt, 'quarterly' for the purpose of this Article means one quarter of a calendar year)

FORM OF PERMITS

10. Article 22I of the Order of 2003 is hereby amended as follows:

- (i) At all times during which the vehicle is left in a parking place specified in Schedule B to this Order between the hours of 8.00am and 9.00am and 5.00pm and 6.00pm on Monday to Friday and between the hours of 8.00am and 6.00pm on Saturday there shall be displayed on the vehicle in the relevant position a valid resident's parking permit issued in respect of the vehicle so that all the particulars referred to in Article 22H of this Order are readily visible from outside the vehicle shall now read,
- (ii) **At all times during which the vehicle is left in a parking place specified in Schedule B to this order between the hours of 8.00am and 9.00am and 5.00pm and 8.00pm on Monday to Friday and between the hours of 8.00am and 8.00pm on Saturday and Sunday there shall be displayed on the vehicle in the relevant position a valid resident's parking permit issued in respect of the vehicle so that all the particulars referred to in Article 22H of this Order are readily visible from outside the vehicle.**

PROVISIONS RELATING TO CONVENIENCE TICKETS

11. Article 22N of the Order of 2003 is hereby amended as follows:

- (i) For the purposes of Article of 22M appropriate payment means:

(a) the payment of the sum of £8.00 per convenience ticket to be used within the twelve month period commencing with the 1st day of April in any year until the 31st March the following year and which is for use when used in conjunction with a resident's parking permit in any of the parking places specified in Part 1 and Part 2 of schedule B to this Order

(b) the payment of the sum of £4.00 per convenience ticket to be used within the twelve month period commencing with the 1st day of April in any year until the 31st March the following year and which is for use when used in conjunction with a resident's parking permit in any of the parking places specified in Part 3 of Schedule B to this Order shall now read,

(ii) For the purposes of Article of 22M appropriate payment means:

(a) the payment of the sum of £9.75 per convenience ticket to be used within within the twelve month period commencing with the 1st day of April in any year until the 31st March the following year and which is for use when used in conjunction with a resident's parking permit in any of the parking places specified in Part 1 and Part 2 of Schedule B to this Order

(b) the payment of the sum of £4.80 per convenience ticket to be used within within the twelve month period commencing with the 1st day of April in any year until the 31st March the following year and which is for use when used in conjunction with a resident's parking permit in any of the parking places specified in Part 3 of Schedule B to this Order.

SCHEDULE 2

12. Schedule 2 to the Order of 2003 is hereby amended as follows:

(i) SCHEDULE 2 No Waiting – Monday to Saturday 8.00am – 6.00pm

Roads or parts of roads in which waiting is restricted between 8.00am and 6.00pm on Monday to Saturday EXCEPT FOR the roads or parts of road specified in Schedule 1 shall now read,

(ii) SCHEDULE 2 No Waiting – Monday to Sunday 8.00am – 8.00pm

Roads or parts of roads in which waiting is restricted between 8.00am and 8.00pm on Monday to Sunday EXCEPT FOR the roads or parts of road specified in Schedules 1 and 14 .

SCHEDULE 5

13. Schedule 5 to the Order of 2003 is hereby amended as follows:

(i) SCHEDULE 5 PAY & DISPLAY BAYS

Ticket Parking Places. Maximum Stay 2 Hours. No Return within 1 Hour Monday to Saturday 8.00am – 6.00pm Width of parking places 2 metres shall now read,

(ii) **SCHEDULE 5 PAY & DISPLAY BAYS**

Ticket Parking Places. Maximum Stay 2 Hours. No Return within 1 Hour Monday to Sunday 8.00am – 8.00pm Width of parking places 2 metres.

- (iii) Column 3 – Days of operation of the parking place - Monday to Saturday shall now read,
- (iv) **Column 3 – Days of operation of the parking place - Monday to Sunday.**
- (v) Column 4 – Hours of operation of the parking place – 8am – 6pm shall now read,
- (vi) **Column 4 – Hours of operation of the parking place – 8.00am – 8.00pm.**

SCHEDULE 12

14. Schedule 12 to the Order of 2003 is hereby amended as follows:

- (i) SCHEDULE 12 Goods Vehicles Loading/Unloading Parking Places Monday to Saturday 8.00am – 6.00pm Maximum Stay 15 Minutes shall now read,
- (ii) **SCHEDULE 12 Goods Vehicles Loading/Unloading Parking Places Monday to Sunday 8.00am – 8.00pm Maximum Stay 15 Minutes.**
- (iii) Column 4 – Days of operation of the loading parking place - Monday to Saturday shall now read,
- (iv) **Column 4 – Days of operation of the loading parking place - Monday to Sunday.**
- (v) Column 5 – Hours of operation of the loading parking place – 8am – 6pm shall now read,
- (vi) **Column 5 – Hours of operation of the loading parking place – 8.00am – 8.00pm.**
- (vii) The loading parking place specified in Schedule 1 to this Order shall be deleted from Schedule 12 to the Order of 2003.

SCHEDULE 13

15. Schedule 13 to the Order of 2003 is hereby amended as follows:

(i) **SCHEDULE 13 PAY & DISPLAY BAYS**

Ticket Parking Places. Maximum Stay 1 Hour. No Return within 1 Hour Monday to Saturday 8.00am – 6.00pm Width of parking places 2 metres shall now read,

(ii) **SCHEDULE 13 PAY & DISPLAY BAYS**

Ticket Parking Places. Maximum Stay 2 Hours. No Return within 1 Hour Monday to Sunday 8.00am – 8.00pm Width of parking places 2 metres.

- (iii) Column 3 – Days of operation of the parking place - Monday to Saturday shall now read,
- (iv) **Column 3 – Days of operation of the parking place - Monday to Sunday.**
- (v) Column 4 – Hours of operation of the parking place – 8am – 6pm shall now read,
- (vi) **Column 4 – Hours of operation of the parking place – 8.00am – 8.00pm.**
- (vii) The loading parking place specified in Schedule 2 to this Order is deleted from Schedule 12 to the Order of 2003.

SCHEDULE B (List of parking places)

- 16. (i) in Part 1 of Schedule B to the Order of 2003 “1 hour maximum stay Pay and Display parking places” shall read as “2 hours maximum stay Pay and Display parking places”
- (ii) in Part 2 of Schedule B to the Order of 2003 “For use by Permit A and Permit B residents permit holders” shall read as “For use by Permit A residents permit holders”.
- (iii) in Part 3 of Schedule B to the Order of 2003 “For use by Permit A Permit B and Permit C residents permit holders” shall read as “For use by Permit A and Permit C residents permit holders”

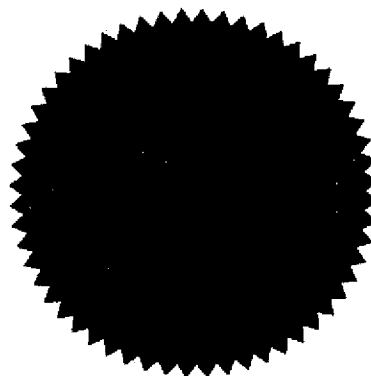
