CITY OF MANCHESTER (VARIOUS ROADS MANCHESTER) (RESERVED LANES FOR BUSES, HACKNEY CARRIAGES AND CYCLES AND REVOCATION) AMENDMENT No 5 ORDER 2012

The Council of the City of Manchester in exercise of its powers under Sections 1(1), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police for the County of Greater Manchester in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

INTERPRETATION

1. (1) In this Order :-

"the Order of 2006" means the City of Manchester (Various Roads, Manchester) (Reserved Lanes for Buses, Hackney Carriages and Cycles and Revocation) Order 2006

(2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

AMENDMENT TO EXISTING ORDER

- 2. The Order of 2006 shall have effect as though:
- a) in Schedule 4 to the Order the length of road specified in Part 1
 of Schedule 1 to this Order was deleted therefrom
- b) in Schedule 5 to the Order the lengths of road specified in Part 2 of Schedule 1 to this Order was deleted therefrom
- in Schedule 11 to the Order the length of road specified in Part 3 of Schedule 1 to this Order was deleted therefrom.
- 3. The Order for 2006 shall have effect as though:
- a) in Schedule 4 to that Order the length of road specified in Part 1 of Schedule 2 to this Order was included therein
- b) in Schedule 5 to that Order the lengths of road specified in Part 2 of Schedule 2 to this Order were included therein
- c) in Schedule 11 to that Order the length of road specified in Part 3 of Schedule 2 to this Order was included therein.

COMMENCEMENT

 This Order shall come into operation on 23rd April 2012 and may be cited as the City Of Manchester (Various Roads Manchester) (Reserved Lanes for Buses, Hackney Carriages and Cycles and Revocation) Amendment No.5 Order 2012.
