Medway Council, having consulted the Chief of Police, in exercise of the powers conferred by sections 1(1), 2(1) to (3), 4(1) and (2) and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984(a) as amended by section 8 of and Part I of Schedule 5 to the Local Government Act 1985(b) and of all other powers thereunto enabling, hereby make the following Order:-

- 1. This Order shall come into force on 30th August 2005 and may be cited as the Medway Council (Waiting and Loading Restriction) (Amendment No.16) Order 2005.
- 2. In this Order "enactment" means any enactment, whether public, general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 3. Without prejudice to the validity of anything done to or to any liability incurred in respect of any act or omission before the coming into force of this Order, the Medway (Prohibition and Restriction of Waiting) Order 2003 shall have effect as though:
 - (a) for the items in Schedule 1 to that Order numbered 32, 88, 112, 169, 202, 212, 221, 267, 275, 306, 376, 384, 419, 460, 466, 506, 536 and 631 there were substituted the items similarly numbered and set out in columns 1, 2 and 3 of Schedule 1 to this Order;
 - (b) for the items in Schedule 2 to that Order numbered 767, and 768 there were added the items similarly numbered and set out in columns 1, 2 and 3 of Schedule 2 to this Order;
 - (c) there were added to Schedule 3 to that Order the item specified in Schedule 3 to this Order.

- (d) there were added to Schedule 2 to that Order the items set out in columns 1, 2 and 3 of Schedule 2 to this o0rder;
- (e) there were added to Schedule 3 to that Order the item set out in Schedule 3 to this Order.
