TRAFFIC REGULATION ORDER

No. 579

The Medway Council (Off-Street Parking Places) (Consolidation) (No. 2, Order 2017) (Amendment No.1) Order 2018

Made: 5th July 2018

Coming into force: 9th July 2018

Medway Council, in exercise of its powers under sections 35 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984¹ and of all other enabling powers, and having consulted the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- 1. This Order shall come into force on Monday 9th July 2018 and may be cited as The Medway Council (Off-Street Parking Places) (Consolidation) (No. 2, Order 2017) (Amendment No. 1) Order 2018.
- 2. (1) In this Order, the expression "enactment" means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment.
 - (2) Any reference in this Order to an enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
 - (3) The Interpretation Act 1978² shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into force of this Order, the Medway Council (Off-Street Parking Places) (Consolidation) (No. 2) Order 2017 shall have effect as though:-
 - (a) in item 22 of Schedule 2 to that Order, for the charging hours specified in column 5 there were substituted the following charging hours: "From 7.00 am on either a Saturday, a Sunday or a bank holiday until 1.00 am on the following day";
 - (b) in items 2, 3, 4, 5, 6, 7, 8, 9, 11, 12, 13, 14, 15, 16, 17 (in both (1) Short Stay and (2) Long Stay), 19, 20, 21, 24, 25, 26, 27, 28, 31, 33, 34, 36, 37 (in both (1) Short Stay and (2) Long Stay), 39, 40, 41, 42, 44, 45, 46, 48, 49, 51, 54, 56, 57, 58, 59, 60, 61, 62, 64, 65, 68 and 69 of Schedule 2 to that Order, for the charging hours specified in column 5 there were substituted the following charging hours: "From 7.00 am on any one day until 1.00 am on the following day":
 - (c) in item 37 of Schedule 2 to that Order, in sub-section (1) Short Stay, for the charging hours specified in column 5 there were substituted the following charging hours: "From 7.00 am on either a Monday, a Tuesday, a Wednesday, a Thursday or a Friday until 1.00 am on the following day";
 - (d) in item 37 of Schedule 2 to that Order, in sub-section (2) Long Stay, for the charging hours specified in column 5 there were substituted the following charging hours: "From 7.00 am on either a Saturday or a Sunday until 1.00 am on the following day".
