

**THE COUNCIL OF THE BOROUGH OF MIDDLESBROUGH
(OFF STREET PARKING PLACES)
(CONSOLIDATION) ORDER 2021**

The Middlesbrough Borough Council ("the Council") in exercise of its powers under Sections 32(1) and 35 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act, and of all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

TITLE AND COMMENCEMENT.

1. This Order shall come into operation on the 18th October 2021 and may be cited as "The Council of the Borough of Middlesbrough (Off Street Parking Places) (Consolidation) Order 2021".

DEFINITIONS

2 (1) Any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order and any reference in this Order to a Schedule is a reference to the Schedule annexed to this Order and any reference to a part of the Schedule shall be construed accordingly.

(2) In this Order: -

"Charging Hours" means

(a) In respect of all Parking Places with the exception of those listed in Parts I and III of the Schedule hereto, the France Street Parking Places as listed in Part II (3) of the Schedule hereto, Civic Centre Parking Places as listed in Part 1V(B)(1) and Part II(12) of the Schedule hereto, Denmark Street Parking Places as listed in Part II(1) of the Schedule hereto, Station Street Parking Places as listed in Part II(2) of the Schedule hereto, Zetland Parking Places as listed in Part II(5) of the Schedule hereto and Gurney Street Parking Places as listed in Part II(10) of the Schedule hereto the period between 8.00am and 6.00pm on any day other than Christmas Day and Sunday.

(b) In respect of the Parking Places listed in Parts I and III of the Schedule hereto, Denmark Street Parking Places as listed in Part II(1) of the Schedule hereto, Station Street Parking Places as listed in Part II(2) of the Schedule hereto, Zetland Parking Places as listed in Part II(5) of the Schedule hereto and Gurney Street Parking Places as listed in Part II(10) of the Schedule hereto, with the exception of the Parkway Centre Car Parks as listed in Part I(5) of the Schedule hereto, the period between 8.00am and 6.00pm on any day other than Christmas Day.

(c) In respect of the France Street Parking Place as listed in Part 11(3) of the Schedule hereto the period between 8.00am and 6.00pm on any day other than Saturdays, Sundays and Bank Holidays.

(d) In respect of the Civic Centre Parking Place as listed in Part IV(B)(1) of the Schedule hereto the period between 8.00am and 6.00pm on Saturdays only other than if Christmas Day falls on a Saturday.

(e) In respect of the Parkway Centre Car Parks designated disabled bays as listed in Part I(5) of the Schedule hereto at any time.

(f) In respect of the Civic Centre Parking Places as listed in Part II (12) of the Schedule hereto the period between 8.00am and 6.00pm Monday to Friday.

(g) In respect of the Parking Places around the perimeter of the Civic Centre building as listed in Part II (13) of the Schedule hereto the period between 8.00am to 6.00pm Monday to Friday for the visitor parking spaces and at all times for the dedicated disabled parking spaces.

"Civil Enforcement Officer" means a person authorised by or on behalf of the Council to supervise a Parking Place as referred to by S.76 of the Traffic Management Act 2004.

"Disabled Persons Badge" means a badge which is issued by either the Council or any other local authority in the United Kingdom or has the effect as if so issued to a disabled person or an institution under the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 or under regulations having effect in Scotland or Wales under section 21 of the Chronically Sick and Disabled persons Act 1970 and has not ceased to be in force.

"Disabled Persons Motor Vehicle" shall include an Invalid Carriage and any other Motor Vehicle in respect of which a permit has been issued under Article 9(2) of this Order

"Driver" in relation to a Motor Vehicle waiting in a Parking Place means the person who was driving the Motor Vehicle at the time it was left in the Parking Place and for the purposes of this Order and of any legal proceedings taken thereunder if on the date a Motor Vehicle is left in a Parking Place a person is shown to have been the registered owner or keeper thereof by notification in writing from the appropriate registration authority he shall be deemed to have been the Driver of the Motor Vehicle on that date unless the contrary is proved.

"Goods Vehicle" has the meaning assigned to it in Section 192 of the Road Traffic Act 1988.

"Invalid Carriage" means that ascribed to it in section 20 of the Chronically Sick and Disabled Persons Act 1970.

"Motor Vehicle" means that ascribed to it in section 185 of the Road Traffic Act 1988

"Parking Place" means an area of land specified by name and more particularly described in column 1 of the Schedule hereto and shown on plan numbered CP1

annexed hereto provided by the Council under Section 32(1) of the Act for use as a Parking Place.

"Parking Bay" means any area of a Parking Place which is provided for the leaving of a Motor Vehicle and indicated by markings on the surface of the Parking Place.

"Parking Ticket" means a ticket issued by a ticket machine and use of the term in the plural shall mean a number of tickets issued by such a machine.

"Season Ticket" means a ticket purchased from the Council to allow use of a Parking Place for a period specified therein..

"Ticket Machine" means an apparatus or device approved in accordance with Section 35(3), 35(3A) or 35(3B) of the Act.

USE OF LAND AND PARKING PLACE

3 (1) Each Parking Place specified in Parts II, III, IV, V & VI of the Schedule hereto may be used, subject to the following provisions of this Order, in such manner and on such days and during such hours and subject to such charges as are specified in relation to it in this Order and the Schedule hereto as a place to park all classes of Motor Vehicles except: -

(a) in respect of Captain Cook Square Multi-Storey Car Park as listed in Parts I(2) and III(1) of the Schedule hereto — any Goods Motor Vehicle, caravan, Motor Vehicle or trailer either of an unladen weight exceeding 2500 kg or of a height exceeding 2.1 metres.

(b) in respect of Zetland Multi-Storey Car Park as listed in Part II(5) of the Schedule hereto — any Goods Motor Vehicle, caravan, Motor Vehicle or trailer either of an unladen weight exceeding 2000 kg or of a height exceeding 1.90 metres.

(c) in respect of North Ormesby Market Place Car Park as listed in Part VI(1) of the Schedule hereto part of the car park indicated by barriers, signs & market stalls as appropriate to be reserved for the exclusive use of market traders authorised by the Council from 7am to 6pm on Tuesdays, Saturdays and on any other day at the absolute discretion of the Council.

(d) in respect of any other Parking Place or part of a Parking Place not mentioned in (a), (b) or (c) above — any Goods Motor Vehicle, caravan, Motor Vehicle or trailer of an unladen weight exceeding 3048 kg.

(2) Each Parking Place specified in Part V of the Schedule hereto may be used as a Parking Place by Goods Vehicles, buses and coaches only, in such a manner and on such days and during such hours and subject to such charges as are specified in relation to it in this Order and the Schedule hereto.

(3) Where, within a Parking Place there is a sign or surface marking which indicates that a Parking Bay is available only for: -

- (a) a Disabled Persons Motor Vehicle,
- (b) a Motor Vehicle bearing a permit issued under Article 4(2)(b), or
- (c) motorcycles

the Driver of a Motor Vehicle shall not cause suffer or permit it to wait in that Parking Bay unless it is a Disabled Persons Motor Vehicle, a Motor Vehicle bearing such a permit or motorcycle parked in the appropriate bay as the case may be.

(4) A Motor Vehicle left in a Parking Place shall be positioned wholly within the marked boundaries of a Parking Bay.

(5) The car parks specified in the schedule hereto may be temporarily subject to a change of use, other than that of a public car park to allow parking for events.

AMOUNT AND PAYMENT OF CHARGE

4 (1) Insofar as a Motor Vehicle or trailer is left in a Parking Place specified in Parts I, II, III, IV(A) or V of Schedule 1 the Driver thereof shall pay such charge or charges as are specified in the following provisions of this Order and Schedule 1.

4 (2) The charge, referred to in Paragraph (1) of this Article shall be payable on the leaving of a vehicle or trailer in a parking place;

- (a) by the insertion of the appropriate coin or coins into a ticket machine and thereby purchasing a ticket, or
- (b) by purchasing from the Council a Season Ticket or Parking Permit entitling a Motor Vehicle to park in any Parking Place specified in Part 1, Part II, Part III, Part IV and Part V of the Schedule during the period of its validity.
- (c) by making an appropriate credit/debit card payment by mobile phone or via the internet to a service provider appointed by the Council.

4 (3) Unless payment has been made in accordance with paragraph 3 (c), upon payment of the parking charge for a vehicle/trailer left in a parking place the driver thereof shall exhibit on the vehicle in accordance with the provisions of paragraph (4) of this Article, a ticket issued by the ticket machine relating to that parking place or parking bay in which the vehicle/trailer is left. The ticket issued in respect of a trailer SHALL be exhibited on the vehicle towing it in the same manner as the ticket issued in respect of the vehicle.

4 (4) The ticket(s) referred to in paragraph (3) of this Article shall be so exhibited on the inside of the vehicle in a conspicuous position so that the date and time of issue shown on the front of the said ticket(s) is clearly visible from outside the vehicle.

4 (5) Where a ticket is exhibited on a vehicle in accordance with the provisions of paragraph (4) of this Article, no person, not being the driver of the vehicle, shall remove the ticket from the vehicle unless authorised to do so by the driver.

4 (6) If at any time while a vehicle/trailer is left in a parking place, on such days and during such hours as are specified in Part I, II, III, IV (A) and V of the Schedule to this Order, no ticket or tickets are exhibited on that vehicle in accordance with paragraph (4) of this Article and payment has not been made in accordance with paragraph 3 (c), it shall be presumed, unless the contrary is proved, that the parking charge has not been duly paid.

PARKING CONTRAVENTIONS

5 (1) A parking contravention pursuant to the provisions of Section 73 of the Traffic Management Act occurs where in relation to a Motor Vehicle left in a Parking Place specified in Part I, II, III, IV (A), V & VI of the Schedule a Driver: -

(a) has not purchased or obtained and displayed a Parking Ticket or tickets or a Season Ticket or Parking Permit or made a credit/debit card payment by mobile phone or via the internet in accordance with Article 4, or

(b) has purchased or displayed a Parking Ticket or tickets for less than the charge payable in accordance with this Order and the Schedule, or

(c) has left a Motor Vehicle for more than the permitted time in that Parking Place, or

(d) where in relation to a Motor Vehicle left in a Parking Place specified in Part IV(A) has returned to that Parking Place with that Motor Vehicle within a period of two hours from the end of the previous period of waiting by that Motor Vehicle.

(e) has left a Motor Vehicle parked in a restricted area of the car park

(f) has left a Motor Vehicle parked in a permit bay without clearly displaying a valid permit.

(g) has left a Motor Vehicle parked beyond the bay markings

(h) has left a Motor Vehicle parked in a disabled person's parking place without clearly displaying a valid disabled person's badge in accordance with The Disabled Persons (Badges for Motor Vehicles)(England) Regulations 2000 (Part III)

(i) has left a Motor Vehicle parked that exceeds the maximum weight and/or height permitted in that Parking Place

(j) has left a Motor Vehicle parked in an area not designated for that class of vehicle

(k) has left a Motor Vehicle parked causing an obstruction.

(l) has left a Motor Vehicle parked in an electric vehicle charging bay for longer than 2 hours, returned to the same electric charging bay within the same day or without connecting to the electric vehicle charging point.

5 (2) A parking contravention pursuant to the provisions of Section 73 of the Traffic Management Act occurs where in relation to a Motor Vehicle left in a Parking Place specified in Part IV(B) of the Schedule a Driver: -

(a) has left a Motor Vehicle for more than the permitted time in that Parking Place, or

(b) has returned to that Parking Place with that Motor Vehicle within a period of two hours from the end of a previous period of waiting by that Motor Vehicle

(c) has left a Motor Vehicle parked in a restricted area of the car park

(d) has left a Motor Vehicle parked in a permit bay without clearly displaying a valid permit.

(e) has left a Motor Vehicle parked beyond the bay markings

(f) has left a Motor Vehicle parked in a disabled person's parking place without clearly displaying a valid disabled person's badge in accordance with The Disabled Persons (Badges for Motor Vehicles)(England) Regulations 2000 (Part III)

(g) has left a Motor Vehicle parked that exceeds the maximum weight and/or height permitted in that Parking Place

(h) has left a Motor Vehicle parked in an area not designated for that class of vehicle

(i) has left a Motor Vehicle parked causing an obstruction.

RESTRICTION ON REMOVAL OF NOTICES

6(1) When a Ticket or Tickets or Season Ticket has been attached to a Motor Vehicle in accordance with any of the foregoing provisions of this Order no person other than the Driver or a person authorised by the Driver shall remove the same from the Motor Vehicle.

EXEMPTION FROM PARKING AND CHARGE RESTRICTIONS

7 (1) The Driver of an Invalid Carriage shall be exempt from any limitation of time and from the payment of any charge specified in this Order and the Schedule.

(2) Any Motor Vehicle which has displayed in a conspicuous position a Disabled Persons Badge together with a parking disk (upon which the driver or other person in charge of the vehicle has marked the time at which the period of waiting began) shall

be exempted from any charge or limitation of time that would otherwise be imposed by this Order and Schedule

(3) The Driver of a Motor Vehicle who has been given a permit in writing by or on behalf of the Council, subject to such conditions as the Council think fit, exempting him from any such charge or limitation of time, provided that the permit is attached in a conspicuous position to the Motor Vehicle in respect of which it was issued and that the Motor Vehicle is parked wholly within a bay reserved only for permit holders.

(4) The Driver of a motor cycle which is parked wholly within a designated Parking Bay shall be exempt from the payment of any such charge.

MOVEMENT AND REMOVAL OF MOTOR VEHICLES

8(1) If a Motor Vehicle is left in a Parking Place in a position other than in accordance with the foregoing provisions of this Order a person authorised by the Council may alter or cause to be altered the position of that Motor Vehicle so that its position is in accordance with the provisions of this Order.

(2) Where a Motor Vehicle has been left in a Parking Place -in contravention of any of the foregoing provisions of this Order a person duly authorised by the Council may remove the Motor Vehicle from the Parking Place or arrange for such removal.

(3) For the purpose of meeting the requirements of an emergency a person authorised by the Council or a Police Constable in uniform may alter or cause to be altered the position of a Motor Vehicle in a Parking Place or remove or arrange for the removal of a Motor Vehicle from a Parking Place.

(4) Any person altering or causing the alteration of the position of a Motor Vehicle or removing or causing the removal of a Motor Vehicle by virtue of this Article may do so by towing or driving the Motor Vehicle or in any such other manner as he may think reasonably necessary to enable the position of the Motor Vehicle to be altered or the Motor Vehicle to be removed.

(5) Any person removing or arranging for the removal of a Motor Vehicle by virtue of Paragraphs (2) or (3) of this Article shall make such arrangements as he considers to be reasonably necessary to ensure the security of the Motor Vehicle in the place to which it is removed.

OTHER PROVISIONS

9. The Driver of a Motor Vehicle using a Parking Place shall stop the engine as soon as the Motor Vehicle is in a position in the Parking Place and shall not start the engine except when about to change the position of the Motor Vehicle in or to depart from the Parking Place.

10. No person shall use cause or permit to be used a Motor Vehicle while it is in a Parking Place, in connection with the sale of any article to persons in or near the Parking Place or in connection with the selling or offering for hire of his skill or services and no person shall while a Motor Vehicle is in a Parking Place affix or place thereon any advertisement without the written consent of the Council which may be issued or withheld at its absolute discretion.

11. The Driver of a Motor Vehicle using a Parking Place shall not sound any horn or other similar instrument except when about to change the position of the Motor Vehicle in or to depart from the Parking Place.

12. No person shall use cause or permit to be used any part of a Parking Place or any Motor Vehicle left in a Parking Place: -

(a) for sleeping or camping or cooking;

(b) for the purpose of servicing or washing any Motor Vehicle or part thereof other than is reasonably necessary to enable that Motor Vehicle to depart from the Parking Place;

(c) for the purpose of selling any article or advertising any services to persons in or near the Parking Place or in connection with the selling or offering for hire of skills or services.

13. In a Parking Place no person shall: -

(a) erect or cause or permit to be erected any tent, booth, stand, building or other structure without the written consent of the Council which may be issued or withheld at its absolute discretion;

(b) cause or permit to be lit any fire;

(c) play or take part in any game;

(d) wantonly shout or otherwise make a loud noise to the nuisance or annoyance of users of the Parking Place or residents or occupiers of premises in the neighbourhood.

14. Where in a Parking Place signs are erected or surface markings are laid for the purpose of: -

(a) indicating the entrance to or exit from the Parking Place, or

(b) indicating that a Motor Vehicle using the Parking Place shall proceed in a specified direction within the Parking Place,

no Driver shall drive any Motor Vehicle (i) so that it enters the Parking Place otherwise than by an entrance, or leaves the Parking Place otherwise than by an exit, so indicated, or (ii) in a direction other than so specified.

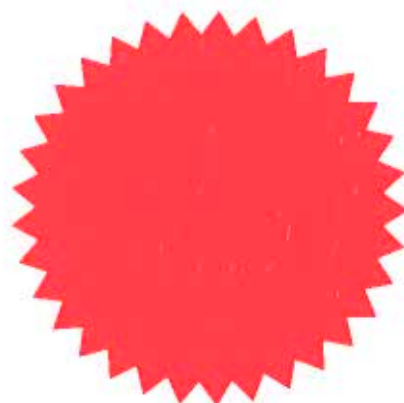
15. No Driver shall, except with the permission of a person authorised by or on behalf of the Council drive any Motor Vehicle in a Parking Place for any purpose other than the purpose of leaving that Motor Vehicle in a Parking Place in accordance with the provisions of this Order or for the purpose of departing from the Parking Place.

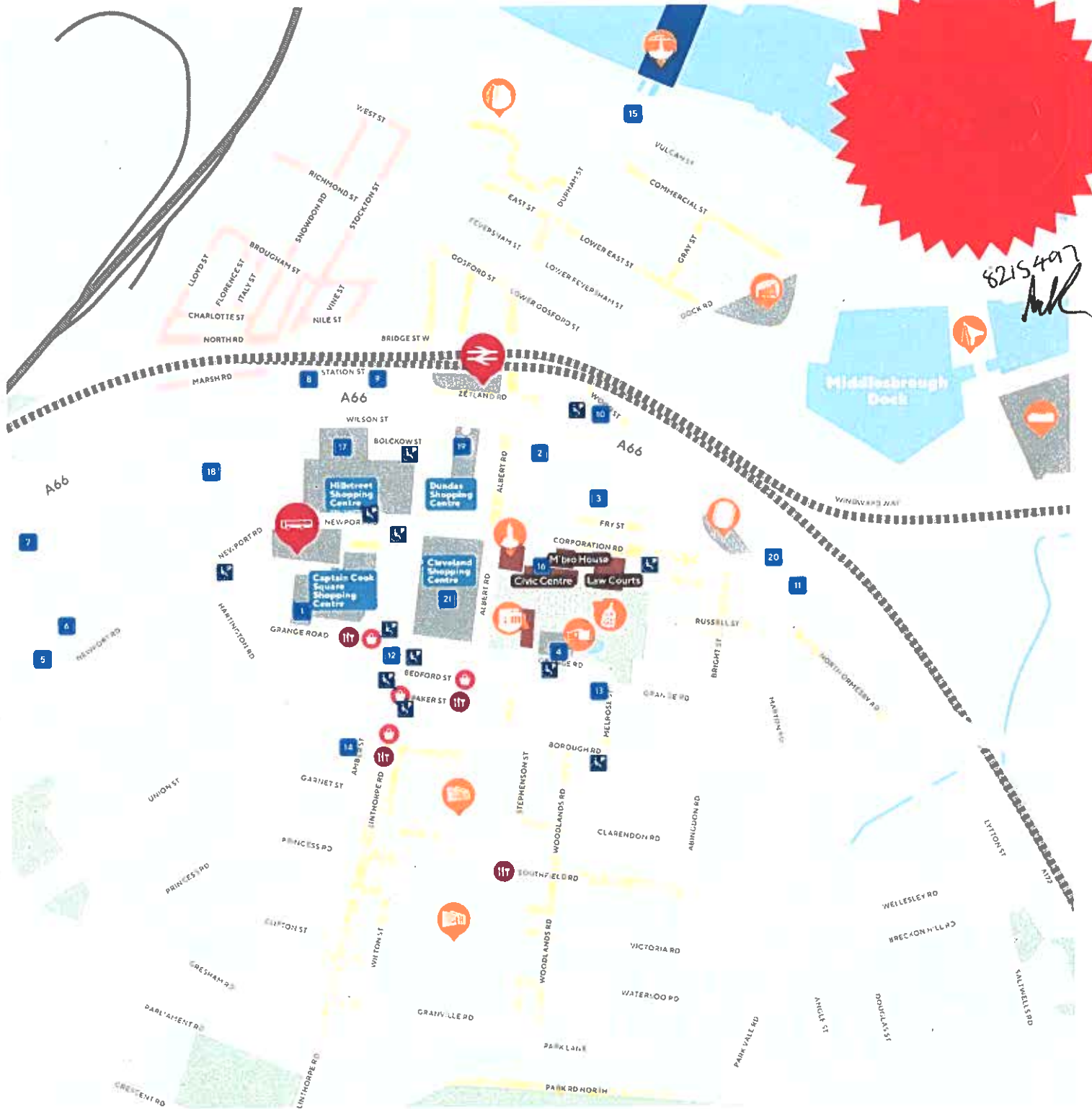

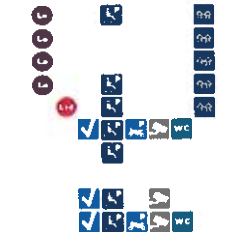

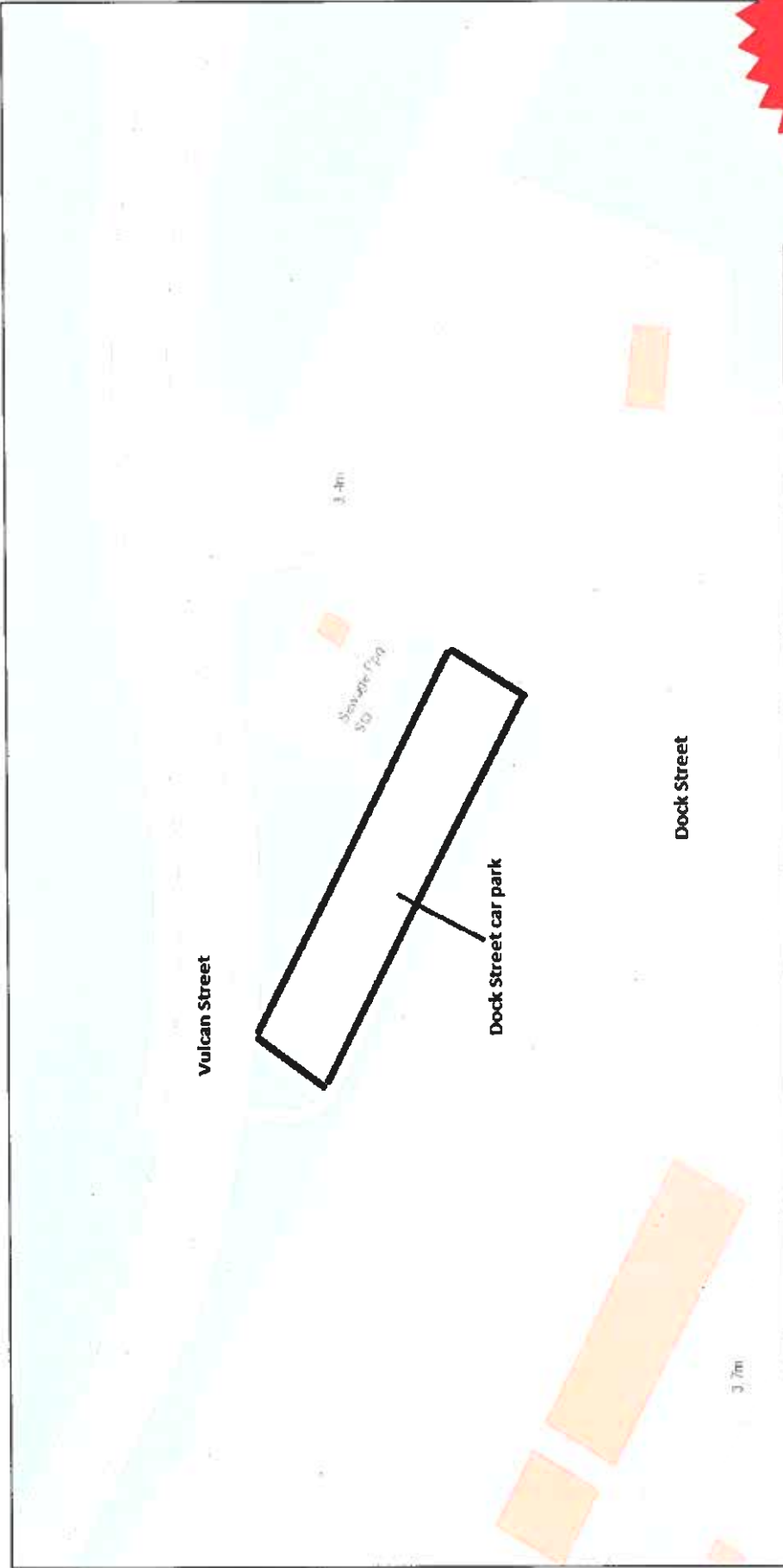
