

**THE COUNCIL OF THE BOROUGH OF MILTON KEYNES

(VARIOUS ROADS, MIDDLETON) (RESIDENTS PERMIT PARKING
AREA) ORDER 2012) VARIATION ORDER 2017**

The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under sections 1(1), 2(1) and (2), 4(2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

PART 1

IMPLEMENTATION AND CIATATION

1. This Order shall come into operation on the 17th day of November 2017 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Various Roads, Middleton) (Residents Permit Parking Area) Order 2012) Variation Order 2017".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order any provisions of any Orders mentioned in the Schedule hereto are hereby revoked to the extent stated in that Schedule

PART 2

VARIATIONS

4. The Council of the Borough of Milton Keynes (Various Roads, Middleton) (Residents Permit Parking Area) Order 2012 ("The Principal Order") is varied as provided by the following provisions of this Order:-
5. Remove all reference to Schedule 1 Part A from Articles 10(1) and (2), 11, 14 in Part 2 of the Principal Order
6. Remove all reference to Schedule 1 Part A from Article 19(1) in Part 3A of the Principal Order.
7. Remove all reference to Schedule 1 Part A from Articles 29(1) and (3) and 30(3)(b) in Part 3C of the Principal Order.
8. Article 19(2) in Part 3A of the principal Order is revoked and replaced by the following:-

19. (2) Any such application shall be made on a form issued by the Council and shall include the information required by such form and shall be accompanied by a remittance, if applicable, for such charge as is specified in items 1 and 3 of Schedule 5
9. Article 21(1) in Part 3A of the principal Order is revoked and replaced by the following:-
 21. (1) If a resident's permit is mutilated or defaced or the figures or particulars on it have become illegible or the colour of the resident's permit has become altered by fading or otherwise, the holder of the resident's permit shall surrender it to the Council and may apply to the Council for the issue to him of a replacement resident's permit and the Council, upon receipt of the resident's permit if such receipt is accompanied by an application for a replacement resident's permit and by a remittance, if applicable, for such charge as is specified in item 6 of Schedule 5, shall issue a replacement resident's permit so marked
10. Article 21(2) in Part 3A of the principal Order is revoked and replaced by the following:-
 21. (2) If a resident's permit is lost or destroyed, the holder of a resident's permit may apply to the Council for the issue to him of a replacement resident's permit and the Council; upon being satisfied as to such loss or destruction, and upon receipt by the Council of an application for a replacement resident's permit and by a remittance, if applicable, for such charge as is specified in item 6 of Schedule 5 shall issue a replacement resident's permit so marked
11. Article 24(2) in Part 3B of the principal Order is revoked and replaced by the following:-
 24. (2) Any such application shall be made on a form issued by the Council and shall include the information required by such form and shall be accompanied by a remittance, if applicable, for such charge as is specified in items 2 and 4 of Schedule 5
12. Article 26(1) in Part 3B of the principal Order is revoked and replaced by the following:-
 26. (1) If a visitor's permit is mutilated or defaced or the figures or particulars on it have become illegible or the colour of the visitor's permit has become altered by fading or otherwise, the holder of the a visitor's permit shall surrender it to the Council and may apply to the Council for the issue to him of a replacement a visitor's permit and the Council, upon the receipt of the visitor's permit if such receipt is accompanied by an application for a replacement visitor's permit and shall be accompanied by a remittance, if applicable, for such charge as is specified in item 6

of Schedule 5 shall issue a replacement visitor's permit so marked

13. Article 26(2) in Part 3B of the principal Order is revoked and replaced by the following:-

26. (2) If a visitors permit is lost or destroyed, the holder of the visitors permit may apply to the Council for the issue to him of a replacement visitors permit and the Council, upon receipt of an application for a replacement visitors permit and shall be accompanied by a remittance, if applicable, for such charge as is specified in item 6 of Schedule 5 and upon being satisfied as to such loss or destruction, shall issue a replacement visitors permit so marked

14. Article 29(1) in Part 3C of the principal Order is revoked and replaced by the following:-

29. (1) Any such application shall be made on a form issued by the Council and shall include the information required by such form and shall be accompanied by a remittance, if applicable, for such charge as is specified in item 5 of Schedule 5

15. Schedule 5 of the principal Order is revoked and replaced by the following:-
