WAITING) ORDER 2010) VARIATION ORDER 2019**

The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under sections 1(1), 2(1) and (2), 4(2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

PART 1

IMPLEMENTATION AND CIATATION

1. This Order shall come into operation on the 27th day of September 2019 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Various Roads, Shenley Church End) (Prohibition of Waiting) Order 2010) Variation Order 2019".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plan and Schedules it is the wording of the Schedules which shall prevail.
4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Various Roads, Shenley Church End) (Prohibition of Waiting) Order 2010 and form part of that Order.
5. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order any provisions of any Orders mentioned in Part 3 hereto are hereby revoked to the extent stated in that Part.

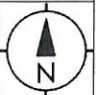

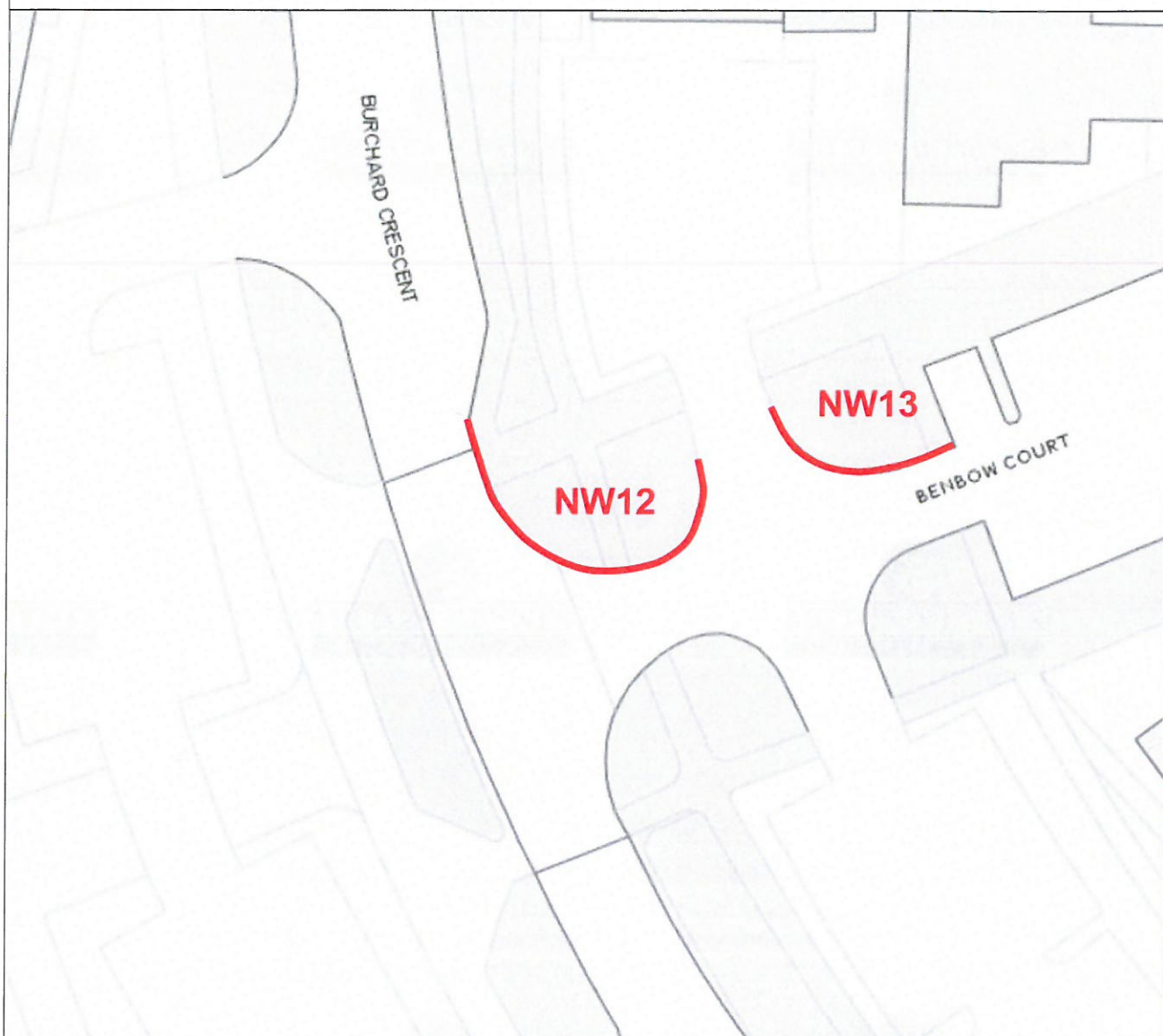

7. Item NW4 in Schedule 1 of the Principal Order is revoked and replaced with the following:-

ENGAIN DRIVE (CENTRAL RESERVATION)

NW4 The full circumference of the central reservation from its junction with Burchard Crescent, a total distance of 86.3 metres

8. The following items are inserted into Schedule 1 of the Principal Order:-

BURCHARD CRESCENT AND BENBOW COURT

EAST SIDE AND NORTH SIDE

NW12 From a point on Burchard Crescent 16 metres north of the centreline of its junction with Benbow Court, for a distance of 28 metres in a southerly then easterly direction into Benbow Court

BENBOW COURT

NORTH SIDE

NW13 From a point 30.2 metres east of its junction with Burchard Crescent, for a distance of 14.5 metres in a westerly then northerly direction
