VARIATION ORDER 2017**

The Council of the Borough of Milton Keynes (hereinafter referred to as “the Council”) in exercise of their powers under Sections 45, 46, 49 and 53 and part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (“the Act of 1984”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

**PART 1**

**IMPLEMENTATION AND CITATION**

1. This Order shall come into operation on 1<sup>st</sup> April 2017 and may be cited as “The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Central Milton Keynes) (Off-Street Pay and Display and Pay by Mobile Phone and Disabled Persons Parking Places and Various Permits) Order 2013) Variation Order 2017”.
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

**PART 2**

**VARIATIONS**

3. The Council of the Borough of Milton Keynes (Central Milton Keynes) (Off-Street Pay and Display and Pay by Mobile Phone and Disabled Persons Parking Places and Various Permits) Order 2013 (“The Principal Order”) is varied as provided by the following provisions of this Order:-

4. The wording "Employee Permit Scratch-Card" and "Scratch-Cards" shall be removed from Articles 38, 38(1), 38(2) and 39 in Part 5 of the principal Order.

### **REVOCATIONS**

5. The following Order is HEREBY REVOKED to the extent stated below:-

Part 7 IS HEREBY REVOKED IN ITS ENTIRETY;

Items 3 and 4 in Schedule 2A ARE HEREBY REVOKED IN ITS ENTIRETY.
