# PART 1

- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

### **VARIATIONS**

The Council of the Borough of Milton Keynes (Central Milton Keynes) (Off-Street Pay and Display and Pay by Mobile Phone and Disabled Persons Parking Places and Various Permits) Order 2013 ("The Principal Order") is varied as provided by the following provisions of this Order:- 4. The wording "Employee Permit Scratch-Card" and "Scratch-Cards" shall be removed from Articles 38, 38(1), 38(2) and 39 in Part 5 of the principal Order.
