# THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (CENTRAL MILTON KEYNES) (ON-STREET STANDARD RATE PAY AND DISPLAY PARKING PLACES AND VARIOUS PERMITS) ORDER 2002) VARIATION ORDER 2003

The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under Sections 45, 46, 49 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

#### PART 1

# IMPLEMENTATION, CITATION AND DEFINITIONS

- This Order shall come into operation on the 4<sup>th</sup> of July 2003 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Standard Rate Pay and Display Parking Places and Various Permits) Order 2002) Amendment Order 2003".
- 2. In this Order, except where the context otherwise requires, the following expressions have the meanings respectively assigned to them:-
  - "five-hour employee permit scratch-card" means an employee permit scratch-card that is valid for a maximum of five hours on a single day; "single day" means a twenty-four hour period commencing at 00:01 hours and concluding at 24:00 hours.
- 3. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- 4. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order any provisions of any Orders mentioned in Schedule 1 hereto are hereby revoked to the extent stated in that Schedule.
- 5. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plans and the Articles it is the wording of the Articles which shall prevail.
- 6. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Standard Rate Pay and Display Parking Places and Various Permits) Order 2002 and forms part of the Order.

#### PART 2

#### **VARIATIONS**

- 7. The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Standard Rate Pay and Display Parking Places and Various Permits) Order 2002 ("The Principal Order") is varied as provided by the following provisions of this Order.
- 8. The following will be inserted into Part 6 of the Principal Order:
  - "62A. Alternatively, a five-hour Employee Permit Scratch-Card shall display the following particulars:
    - (1) A clock showing fifteen minute period blocks from 07:00 to 18:00 inclusive;
    - (2) Day numbers from 1 to 31 inclusive;
    - (3) The months from January to December inclusive;
    - (4) The years in which that Permit Scratch-Card may be used;
    - (5) An authentication that the Permit Scratch-Card has been issued by the Council."
- 9. The following will be in addition to Part 6 of the Principal Order:

  "64A. Alternatively, a five hour Employee Permit Scratch-Card shall only be valid when the date and hours of use are indicated by the scratching-off of:
  - (1) up to twenty blocks of fifteen minutes from the clock;
  - (2) one day;
  - (3) one month; and
  - (4) one year."
- 10. Article 65 of the Principal Order is revoked and replaced by"65. A five-hour Employee Permit Scratch-Card shall become invalid:
  - (1) if more than five hours are scratched-off the Permit Scratch-Card;
  - (2) if more than one day is scratched-off the Permit Scratch-Card;

- (3) if more than one month is scratched-off the Permit Scratch-Card;
- (4) if more than one year is scratched-off the Permit Scratch-Card."
- 11. The following will be in addition to Part 6 of the Principal Order:
  "65A Alternatively, a five-hour Employee Permit Scratch-Card shall become invalid:
  - (1) if more than twenty blocks of fifteen minutes are scratched-off the Permit Scratch-Card;
  - (2) if more than one day is scratched-off the Permit Scratch-Card;
  - (3) if more than one month is scratched-off the Permit Scratch-Card;
  - (4) if more than one year is scratched-off the Permit Scratch-Card."
- 12. Item PS2a for Witan Gate East in Schedule 1 of the Principal Order is revoked and replaced by:
  - THE SOUTH-WEST VEHICULAR ACCESSWAY SOUTH-WEST SIDE PS2a From a point 26.3 metres north-west of the access road from Witan Gate (between North Row and Silbury Boulevard) in a north-westerly direction for a distance of 57.8 metres.
- 13. Item PS6f for Saxon Gate West in Schedule 1 of the Principal Order is revoked and replaced by:
  - THE NORTH-EAST VEHICULAR ACCESSWAY NORTH-EAST SIDE
    PS6f From a point 38.3 metres north-west of the access road from
    Saxon Gate (between North Row and Silbury Boulevard) in a
    north-westerly direction for a distance of 47.2 metres.
- 14. Item PS19d for Witan Gate East in Schedule 1 of the Principal Order is revoked and replaced by:
  - THE SOUTH-WEST VEHICULAR ACCESSWAY SOUTH-WEST SIDE PS19d From a point 4.3 metres south-east of the access road from Witan Gate (between Avebury Boulevard and South Row) in a south-easterly direction for a distance of 79.5 metres.
- 15. Item PS22g for Saxon Gate West in Schedule 1 of the Principal Order is revoked and replaced by:
  - THE NORTH-EAST VEHICULAR ACCESSWAY NORTH-EAST SIDE PS22g From a point 4.5 metres south-east of the access road from Saxon Gate (between Avebury Boulevard and South Row) in a south-easterly direction for a distance of 79.9 metres.

- 16. Item PS23d for Saxon Gate East in Schedule 1 of the Principal Order is revoked and replaced by:
  - THE SOUTH-WEST VEHICULAR ACCESSWAY SOUTH-WEST SIDE PS23d From a point 38.3 metres north-west of the access road from Saxon Gate (between Silbury Boulevard and North Row) in a north-westerly direction for a distance of 46 metres.
- 17. Item PS28a for Saxon Gate East in Schedule 1 of the Principal Order is revoked and replaced by:

THE SOUTH-WEST VEHICULAR ACCESSWAY – SOUTH-WEST SIDE PS28a From a point 4.3 metres south-east of the access road from Saxon Gate (between South Row and Avebury Boulevard) in a south-easterly direction for a distance of 80.8 metres.

- 18. Item PS31d for Secklow Gate East in Schedule 1 of the Principal Order is revoked and replaced by:
  - THE SOUTH-WEST VEHICULAR ACCESSWAY SOUTH-WEST SIDE PS31d From a point 4.5 metres north-west of the access road from Secklow Gate (between Silbury Boulevard and North Row) in a north-westerly direction for a distance of 78.6 metres.
- 19. Item PS36a in Schedule 1 of the Principal Order is revoked and replaced by:






- 20. Item PS42c for Grafton Gate West in Schedule 2 of the Principal Order is revoked and replaced by:
  - THE NORTH-EAST VEHICULAR ACCESSWAY NORTH-EAST SIDE PS42c From a point 5.1 metres south-east of the access road from Grafton Gate (between Avebury Boulevard and South Row) in a south-easterly direction for a distance of 89.6 metres.
- 21. Item PS43a for Grafton Gate East in Schedule 2 of the Principal Order is revoked and replaced by:
  - THE SOUTH-WEST VEHICULAR ACCESSWAY SOUTH-WEST SIDE PS43a From a point 4.5 metres north-west of the access road from Witan Gate (between North Row and Silbury Boulevard) in a north-westerly direction for a distance of 79.4 metres.
- 22. Item PS48d for Witan Gate West in Schedule 2 of the Principal Order is revoked and replaced by:


THE NORTH-EAST VEHICULAR ACCESSWAY – NORTH-EAST SIDE PS48d From a point 4.5 metres north-west of the access road from Witan Gate (between North Row and Silbury Boulevard) in a north-westerly direction for a distance of 79.1 metres.


- 23. Item PS68a for Secklow Gate West in Schedule 3 of the Principal Order is revoked and replaced by:
  - THE SOUTH WEST VEHICULAR ACCESS WAY SOUTH-WEST SIDE PS68a From the access road from Secklow Gate between Childs Way and Avebury Boulevard and South Row.
- 24. Item PS68b for Secklow Gate West in Schedule 3 of the Principal Order is revoked and replaced by:
  - THE SOUTH WEST VEHICULAR ACCESSWAY NORTH-EAST SIDE PS68b From the access road from Secklow Gate between Childs Way and Avebury Boulevard and South Row.
- 25. Item PS68c for Secklow Gate West in Schedule 3 of the Principal Order is revoked and replaced by:
  - THE NORTH-EAST VEHICULAR ACCESSWAY SOUTH-WEST SIDE PS68c From the access road from Secklow Gate between Childs Way and Avebury Boulevard and South Row.
- 26. Item PS68d for Secklow Gate West in Schedule 3 of the Principal Order is revoked and replaced by:
  - THE NORTH-EAST VEHICULAR ACCESSWAY NORTH-EAST SIDE PS68d From a point 4.5 metres south-east of the access road from Secklow Gate, between Childs Way and Avebury Boulevard in a south-easterly direction for a distance of 79.4 metres.
- 27. Item LP5c for Grafton Gate West in Schedule 4 of the Principal Order is revoked and replaced by:
  - THE NORTH-EAST VEHICULAR ACCESSWAY NORTH-EAST SIDE LP5c From a point 5.1 metres south-east of the access road from Grafton Gate (between Avebury Boulevard and South Row) in a south-easterly direction for a distance of 89.6 metres.
- 28. Item LP6a for Grafton Gate East in Schedule 4 of the Principal Order is revoked and replaced by:
  - THE SOUTH-WEST VEHICULAR ACCESSWAY SOUTH-WEST SIDE LP6a From a point 4.5 metres north-west of the access road from Witan Gate (between North Row and Silbury Boulevard) in a north-westerly direction for a distance of 79.4 metres.
- 29. Item LP11d for Witan Gate West in Schedule 4 of the Principal Order is revoked and replaced by:
  - THE NORTH-EAST VEHICULAR ACCESSWAY NORTH-EAST SIDE LP11d From a point 4.5 metres north-west of the access road from Witan Gate (between North Row and Silbury Boulevard) in a north-westerly direction for a distance of 79.1 metres.








