

**THE COUNCIL OF THE BOROUGH OF MILTON KEYNES
(VARIOUS ROADS, CENTRAL BLETCHLEY AND FENNY STRATFORD)
(CONSOLIDATION OF PARKING AND WAITING RESTRICTIONS)
ORDER 2002) VARIATION ORDER 2005**

The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under Sections 1(1), 2(1) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

PART 1

IMPLEMENTATION, CITATION AND REVOCATIONS

1. This Order shall come into operation on the 21st of March 2005 and may be cited as "The Council of the Borough of Milton Keynes (Various Roads, Central Bletchley and Fenny Stratford) (Consolidation of Parking and Waiting Restrictions) Order 2002) Variation Order 2005".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plan and the Schedule it is the wording of the Schedule which shall prevail.
4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Various Roads, Central Bletchley and Fenny Stratford) (Consolidation of Parking and Waiting Restrictions) Order 2002 and forms part of the Order.

PART 2

VARIATIONS

5. The Council of the Borough of Milton Keynes (Various Roads, Central Bletchley and Fenny Stratford) (Consolidation of Parking and Waiting Restrictions) Order 2002 ("The Principal Order") is varied as provided by the following provisions of this Order.
6. Item NW76 is revoked in its entirety from Schedule 1 No Waiting At Any Time to the Principle Order and is replaced by:

DENBIGH ROAD SERVICE ROAD – NORTH EAST SIDE

NW76 From its south-eastern end continuing for a distance of 82 metres in a north-easterly direction

7. Item NW77 is revoked in its entirety from Schedule 1 No Waiting At Any Time to the Principle Order and is replaced by:

NW77 From a point 105 metres north-west of its south-eastern end for a distance of 971 metres in a north-westerly direction.

8. Item NW78 is revoked in its entirety from Schedule 1 No Waiting At Any Time to the Principle Order and is replaced by:

DENBIGH ROAD SERVICE ROAD- SOUTH WEST SIDE


NW78 From and including its south-eastern end for a distance of 1076 metres in a north-westerly direction.

9. Item NW157 is revoked in its entirety from Schedule 1 No Waiting At Any Time to the Principle Order.

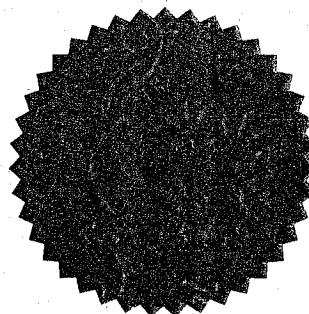
10. Item NW181 is revoked in its entirety from Schedule 1 No Waiting At Any Time to the Principle Order.

11. Item NW254 is revoked in its entirety from Schedule 3 No Waiting Monday to Saturday 8am to 6pm to the Principle Order.

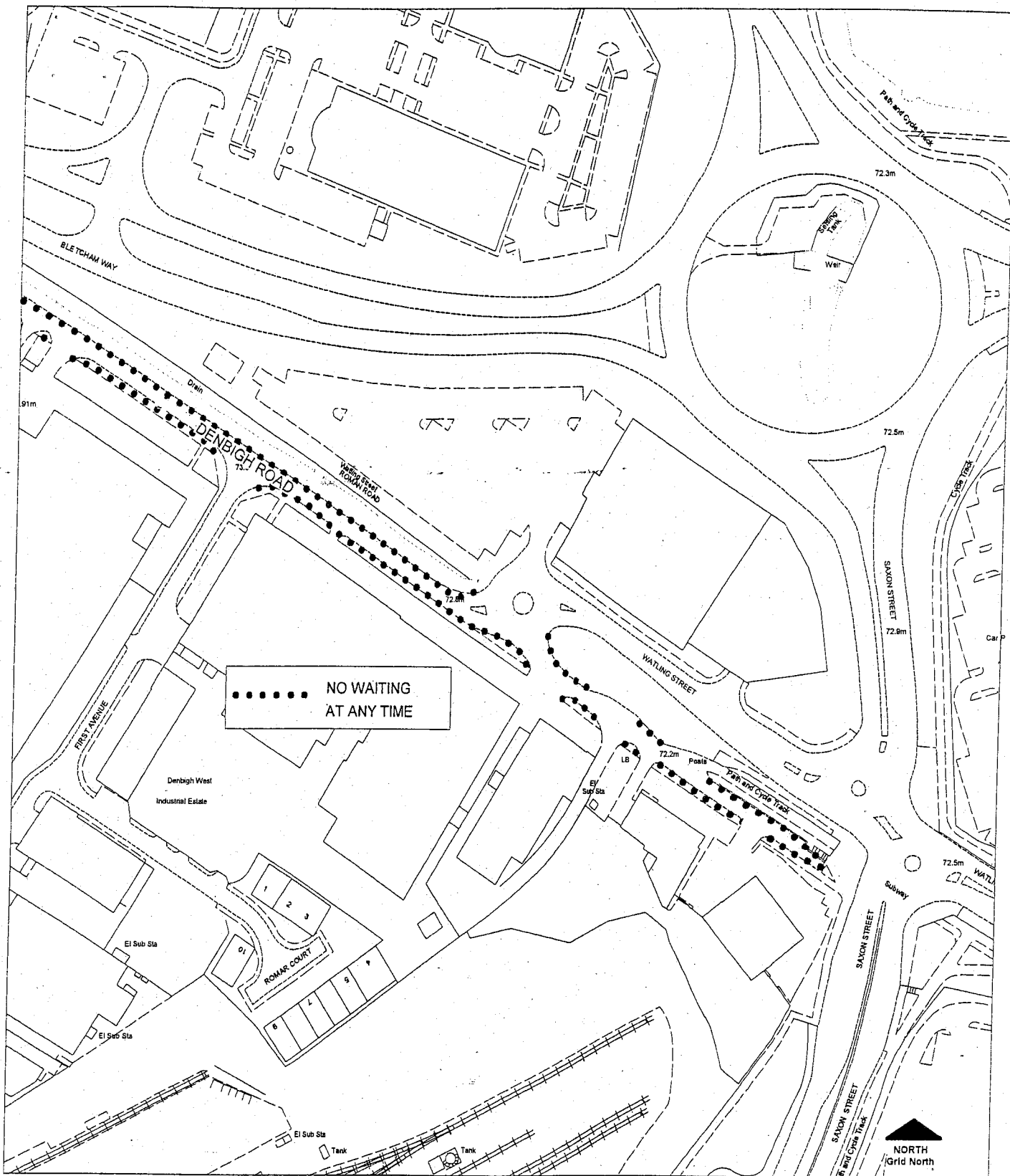

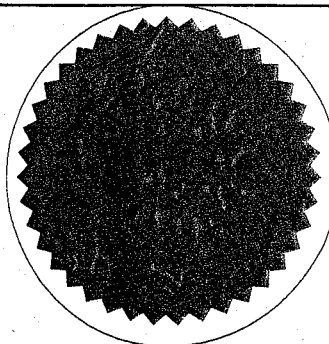
