# THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (CENTRAL MILTON KEYNES) (ON-STREET PREMIUM RATE PAY AND DISPLAY PARKING PLACES) ORDER 2005) VARIATION ORDER 2005

The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under Sections 45, 46, 49 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

### PART 1

# IMPLEMENTATION, CITATION AND DEFINITIONS

- 1. This Order shall come into operation on the 5<sup>th</sup> August 2005 and may be cited as "The Council Of The Borough Of Milton Keynes (The Council Of The Borough Of Milton Keynes (Central Milton Keynes) (On-Street Premium Rate Pay And Display Parking Places) Order 2005) Variation Order 2005".
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

### PART 2

### **VARIATIONS**

3. The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Premium Rate Pay and Display Parking Places) Order 2005 ("The Principal Order") is varied as provided by the following provisions of this Order.

- 4. In Part 2 Variations Article 7 Item (1) in the Principal Order, revoke the following;
  - "The heading of Schedule 1 is substituted as follows:

## **SCHEDULE 1**

# PREMIUM RATE PAY AND DISPLAY PARKING PLACES

EXCEPT WITHIN THE MARKED BICYCLE/MOTOR CYCLE AND DISABLED PERSONS' PARKING PLACES BETWEEN
7.00AM AND 6.00PM MONDAY TO FRIDAY "

and replace with the following;

"The heading of Schedule 1 is substituted as follows:

# **SCHEDULE 1**

# PREMIUM RATE PAY AND DISPLAY PARKING PLACES

EXCEPT WITHIN THE MARKED BICYCLE/MOTOR CYCLE AND DISABLED PERSONS' PARKING PLACES BETWEEN 7.00AM AND 6.00PM EVERY DAY OF THE WEEK"
