PART 1

IMPLEMENTATION, CITATION AND DEFINITIONS


- 1. This Order shall come into operation on the 25th day of November 2005 and may be cited as "The Council Of The Borough Of Milton Keynes (The Council Of The Borough Of Milton Keynes (Central Milton Keynes) (On-Street Residents' Permit Parking Places) Order 2005) Variation Order 2005".
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- 3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plans and the Articles it is the wording of the Articles which shall prevail.
- 4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Residents' Permit Parking Places) Order 2005 and forms part of the Order.

PART 2

VARIATIONS

The Council of the Borough of Milton Keynes (Central Milton Keynes) (On–Street Residents' Permit Parking Places) Order 2005 ("The Principal Order") is varied as provided by the following provisions of this Order:-

(1) The following item is inserted into Schedule 1, Part B of the principal order as follows; NORTH FOURTEENTH STREET THE SOUTH-WEST VEHICULAR ACCESSWAY – NORTH-EAST SIDE RP19 From the junction with North Row to a point 37 metres in a south-easterly direction.
