PART 1


IMPLEMENTATION, CITATION AND DEFINITIONS

- 3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plans and the Articles it is the wording of the Articles which shall prevail.
- 4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Central Milton Keynes) (On–Street Standard Rate Pay and Display Parking Places and Various Permits) Order 2002 and forms part of the Order.

PART 2

VARIATIONS

- 5. The Council of the Borough of Milton Keynes (Central Milton Keynes) (On–Street Standard Rate Pay and Display Parking Places and Various Permits) Order 2002 ("The Principal Order") is varied as provided by the following provisions of this Order:-
 - (1) Item PS36c in Schedule 1 of the principal order is revoked and replaced as follows: NORTH FOURTEENTH STREET



THE SOUTH-WEST VEHICULAR ACCESSWAY – NORTH EAST SIDE

PS36c From the access road from Marlborough Gate to a point 19.6 metres north-west of that point.
