

**THE COUNCIL OF THE BOROUGH OF MILTON KEYNES
(THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (CENTRAL MILTON
KEYNES) (ON-STREET PAY AND DISPLAY PARKING PLACES) ORDER 1999)
VARIATION ORDER 2008**

The Council of the Borough of Milton Keynes ("the Council") in exercise of the powers of the said Council under Sections 45, 46, 49, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 hereby makes the following Order: -

PART 1

IMPLEMENTATION, CITATION AND DEFINITIONS

1. This Order shall come into operation on the 13th day of June 2008 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Pay and Display Parking Places) Order 1999) Variation Order 2008".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plans annexed to this Order identify the lengths of road subject to this Order, provided that where there is any inconsistency between the plans and the Articles it is the wording of the Articles which shall prevail.
4. The plans annexed to this Order are hereby annexed to The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Pay and Display Parking Places) Order 1999 and form part of the Order.

PART 2

VARIATIONS

5. The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Pay and Display Parking Places) Order 1999 ("The Principal Order") is varied as provided by the following provisions of this Order:-

The following items are inserted into Schedule 1 Part B of the Principal Order as follows:

- 1) SILBURY BOULEVARD - THE NORTH-WEST VEHICULAR ACCESSWAY – BOTH SIDES
 - PD83 From Elder Gate (that part which is public highway) to the porte cochere south-west of that point
 - PD84 From the porte cochere south-west of Elder Gate (that part which is public highway) to its south-western extremity
