The Council of the Borough of Milton Keynes (hereinafter referred to as "the Council") in exercise of its powers under sections 1(1), and 2(1) to (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act makes the following order: -

#### PART 1

#### IMPLEMENTATION AND CITATION

- 1. This Order shall come into operation on 1 August 2008 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes (Various Roads, Olney) (Consolidation of Parking and Waiting Restrictions) Order 2002) Amendment Order 2008".
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order any provisions of any Orders mentioned in this Order are hereby revoked to the extent stated in the Schedule to that Order.
- 4. The plan marked The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes (Various Roads, Olney) (Consolidation of Parking and Waiting Restrictions) Order 2002) Amendment Order 2008 annexed hereto is hereby annexed to the Principal Order and forms part of that Order.

#### PART 2

### **AMENDMENTS AND REVOCATIONS**

#### LIME STREET-BOTH SIDES

NW26A – From a point 64 metres south of the junction of Weston Road, continuing for a distance of 62 metres in a south-easterly direction

2. The following item is revoked from Schedule 1 of the Principal Order:

#### LIME STREET - SOUTH WEST SIDE

NW29 – From a point in line with the north-west kerbline of Bridge Street, continuing for 5 metres in a north-westerly direction

and is replaced by

#### LIME STREET- SOUTH WEST SIDE

NW29 – From a point in line with the southwest kerb line of Bridge Street, continuing for 20.5 metres in a north-westerly direction.
