# THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (LOUGHTON) (ON-STREET RESIDENTS SPECIFIC AND PERMIT PARKING ZONE) ORDER 2006) AMENDMENT ORDER 2008

The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under Sections 32(1), 35(1), 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

#### PART 1

#### IMPLEMENTATION AND CITATION

- 1. This Order shall come into operation on the 15th day of September 2008 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes (Loughton) (On-Street Residents Specific and Permit Parking Zone) Order 2006) Amendment Order 2008".
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- 3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plans and the Articles it is the wording of the Articles which shall prevail.
- 4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Loughton) (On-Street Residents Specific and Permit Parking Zone) Order 2006 and forms part of the Order.

#### PART 2

### **AMENDMENTS**

- 5. The Council of the Borough of Milton Keynes (Loughton) (On-Street Residents Specific and Permit Parking Zone) Order 2006 ("The Principal Order") is amended as provided by the following provisions of this Order:-
  - (1) Item CPZ4 in Schedule 1 Part A of the principal order is revoked and replaced with the following:

## BRADWELL ROAD, LOUGHTON - BOTH SIDES

CPZ4 From a point approximately 35 metres north of the northern property boundary of No.94 Bradwell Road to a point approximately 16 metres north of the northern building line of No.15 Bradwell Road.

(2) Item CPZ20 in Schedule 1 Part A of the principal order is revoked and replaced with the following:

REDLAND DRIVE, LOUGHTON - BOTH SIDES

From a point approximately 5.6 metres north of the give way line of Redland Drive CPZ20 and Ashpole Furlong to its junction with Linslade Grove.

(3) The following item is inserted into Schedule 1 Part A and Schedule 1 Part B of the principal order as follows:

KNOWL GATE, LOUGHTON - BOTH SIDES

CPZ24 From the give way line of Knowl Gate and Redland Drive to a point approximately 23.5 metres east from that position.

(4) The heading of Schedule 1 Part B of the principal order is substituted as follows:

## PART B

PARKING ZONE FOR USE BY MOTOR VEHICLES WHICH DISPLAY A RESIDENTS' PERMIT, VISITORS PERMIT, VISITORS PERMIT SCRATCH-CARD, CARER'S PERMIT OR BUSINESS PERMIT OR IF THE MOTOR VEHICLE IS A MOTORCYCLE OR MOPED BETWEEN THE HOURS OF

9.00AM AND 10.00AM & 5.00PM AND 6.00PM MONDAY - SATURDAY INCLUSIVE:

(5) Item 4 in Schedule 2 of the principal order is revoked and replaced with the following:

Visitor's Permit Scratch-Card (For each individual Scratch-Card above 50)

1 day

£2.00

(6) The wording in Article 29 of the principal order is revoked and replaced with the following:

A visitors permit scratch card shall only be valid for the duration of a single day during the prescribed hours indicated in Schedule 1 Part B to this Order.
