The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under Sections 45, 46, 49 and 53 of the Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

PART 1

IMPLEMENTATION AND CITATION

- 1. This Order shall come into operation on the 14th day of November 2008 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes (Residents, Visitors, Carer and Business Permits and Specific Parking Places, Bletchley) Order 2005) Amendment Order 2008".
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- The plans annexed to this Order identify the lengths of road subject to this Order, provided that where there is any inconsistency between the plans and the Articles it is the wording of the Articles which shall prevail.
- The plans annexed to this Order are hereby annexed to The Council of the Borough of Milton Keynes (Residents, Visitors, Carer and Business Permits and Specific Parking Places, Bletchley) Order 2005 and form part of the Order.

PART 2

AMENDMENTS

- 5. The Council of the Borough of Milton Keynes (Residents, Visitors, Carer and Business Permits and Specific Parking Places, Bletchley) Order 2005 ("The Principal Order") is amended as provided by the following provisions of this Order:-
- 6. The heading of Schedule 1 Part A of the principal order is substituted as follows:

PERMIT SCHEME

- (1.) ROADS OR PARTS OF ROADS FROM WHICH RESIDENTS, CARERS MAKING HOUSE CALLS, VISITORS AND BUSINESSES ARE ELIGIBLE TO APPLY FOR PERMITS
- 7. The heading of Schedule 1 Part B of the principal order is substituted as follows:

PARKING PLACES FOR USE ONLY BY VEHICLES WHICH DISPLAY A RESIDENT'S PERMIT, CARER PERMIT, VISITOR'S PERMIT OR BUSINESS PERMIT THE WHOLE 24 HOURS OF EVERY DAY

Victoria Road – All numbers 81 – 95 inclusive; Watling Street – Number 64 only.

- 10. The following items are inserted into Schedule 1 Part B of the Principal Order as follows:-
 - 1) TAVISTOCK STREET SOUTH SIDE

RCB48 From a position approximately 34.6 metres east of a point in line with the eastern boundary wall of No.47 Tavistock Street for a distance of approximately 21 metres in an easterly direction.

NORTH SIDE

RCB49 From a position approximately 60.6 metres east of a point in line with the western boundary wall of No.64 Tavistock Street to a position approximately 14 metres west of a point in line with the western boundary wall of No.36 Tavistock Street.

Street for a distance of approximately 29 metres in an easterly direction.
