

**THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (VARIOUS ROADS WITHIN GREENEYS, WILLEN, EMERSON VALLEY, LOUGHTON, BRADWELL COMMON, DOWNS BARN, FURZTON, SHENLEY LODGE, KENTS HILL, SHENLEY BROOK END, CONNIBURROW, HEELANDS, TWO MILE ASH, BLETCHLEY, FISHERMEAD, SHERINGTON, SPRINGFIELD, STANTONBURY AND NEWPORT PAGNELL)  
(PROHIBITION OF STOPPING) VARIATION ORDER 2008**

The Council of the Borough of Milton Keynes ("the Council") in exercise of the powers of the said Council under Sections 1(1), 2(1) to (3), and (4(2) of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 hereby makes the following Order: -

**PART 1**

**IMPLEMENTATION AND CITATION**

1. This Order shall come into operation on the 1<sup>st</sup> day of December 2008 and may be cited as "The Council of the Borough of Milton Keynes (Various Roads within Greenleys, Willen, Emerson Valley, Loughton, Bradwell Common, Downs Barn, Furzton, Shenley Lodge, Kents Hill, Shenley Brook End, Conniburrow, Heelands, Two Mile Ash, Bletchley, Fishermead, Sherington, Springfield, Stantonbury and Newport Pagnell) (Prohibition of Stopping) Variation Order 2008".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plans annexed to this Order identify the lengths of road subject to this Order, provided that where there is any inconsistency between the plans and the Articles it is the wording of the Articles which shall prevail.

**PART 2**

**VARIATIONS**

4. The Council of the Borough of Milton Keynes (Various Roads within Greenleys, Willen, Emerson Valley, Loughton, Bradwell Common, Downs Barn, Furzton, Shenley Lodge, Kents Hill, Shenley Brook End, Conniburrow, Heelands, Two Mile Ash, Bletchley, Fishermead, Sherington, Springfield, Stantonbury and Newport Pagnell) (Prohibition of Stopping) Order 2008" ("The Principal Order") is varied as provided by the following provisions of this Order:-
