
IMPLEMENTATION AND CITATION


- 1. This Order shall come into operation on 31 January 2011 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Central Milton Keynes) (On-Street Specific and Permit Parking Places) Order 2002) Variation Order 2011".
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- 3. The plan annexed to this Order identifies the length of road subject to this Order, provided that where there is any inconsistency between the plan and the Articles it is the wording of the Articles which shall prevail.
- 4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Central Milton Keynes) (On–Street Specific and Permit Parking Places) Order 2002 and forms part of the Order.



VARIATIONS

- 5. The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Specific and Permit Parking Places) Order 2002 ("The Principal Order") is varied as provided by the following provisions of this Order:-
- 6. The following item is inserted into Schedule 3 of the Principal Order as follows :-
 - AVEBURY BOULEVARD THE SOUTH-EAST VEHICULAR ACCESSWAY – SOUTH-EAST SIDE
 MP23 From a point approximately 7 metres south-west of the porte cochere north-east of South Seventh Street, continuing for a distance of approximately 2.5 metres in a south-westerly direction (1 SPACE)







- 7. The following items are inserted into Schedule 6 of the Principal Order as follows:
 - NORTH ROW THE SOUTH-EAST VEHICULAR ACCESSWAY – SOUTH-EAST SIDE DP110 From the porte cochere north-east of Witan Gate continuing for a distance of approximately 7.3 metres in a north-easterly direction (2 SPACES)
 - 2) NORTH THIRTEENTH STREET SOUTH-WEST SIDE DB111 From the optropose to the Joh
 - DP111 From the entrance to the Job Centre car park continuing for a distance of approximately 7.2 metres in a south-easterly direction (2 SPACES)
 - 3) NORTH FOURTEENTH STREET SOUTH-WEST SIDE
 - DP112 From a point approximately 19.3 metres north-west of the access road onto Marlborough Gate (between North Row and Silbury Boulevard) to a point approximately 5 metres north-west of that point (1 SPACE)
