

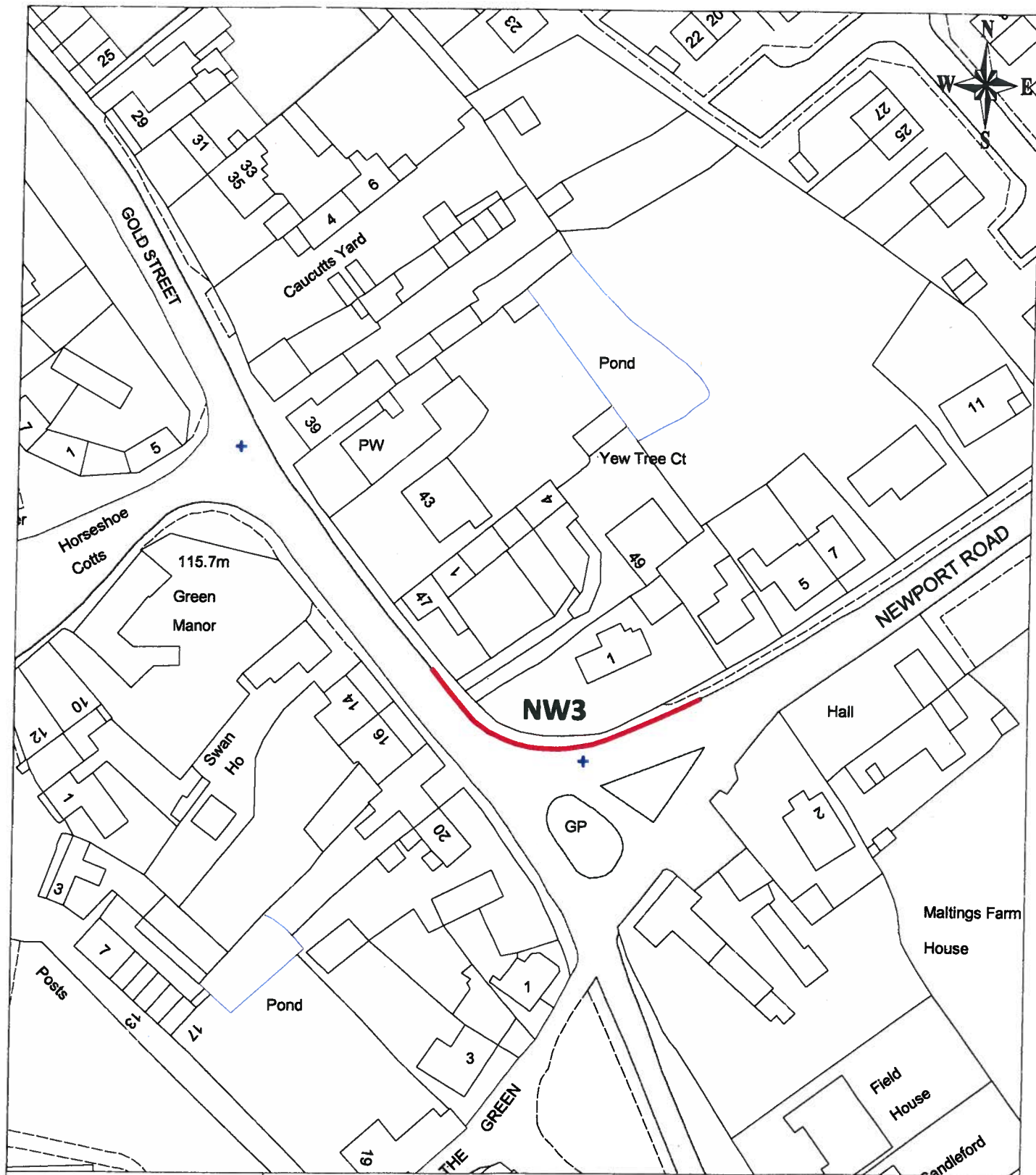
**THE COUNCIL OF THE BOROUGH OF MILTON KEYNES

ORDER 2002) VARIATION ORDER 2011**

The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under Sections 1(1), 2(1) and (2), 4(2), Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:


PART 1

IMPLEMENTATION AND CITATION

1. This Order shall come into operation on the 27th day of May 2011 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes (Various Roads, Hanslope) (Consolidation of Waiting Restrictions) Order 2002) Variation Order 2011".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plan annexed to this Order identifies the length of road subject to this Order, provided that where there is any inconsistency between the plan and the Articles it is the wording of the Articles which shall prevail.
4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Various Roads, Hanslope) (Consolidation of Waiting Restrictions) Order 2002) and forms part of that Order.

**JUNCTION OF GOLD STREET AND NEWPORT ROAD, HANSLOPE
NORTH-EAST SIDE**

NW3 From a point opposite the northern boundary line of numbers 14 and 16 Gold Street, Hanslope, for a distance of approximately 53.5 metres in a south-easterly then north-easterly direction onto Newport Road, Hanslope.
