

**THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (CENTRAL MILTON
KEYNES) (WAITING AND LOADING RESTRICTIONS) ORDER 2002)
VARIATION ORDER 2011**

The Council of the Borough of Milton Keynes ("the Council") in exercise of the powers of the said Council under Sections 45, 46, 49 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 hereby makes the following Order:-

PART 1

IMPLEMENTATION, CITATION AND VARIATIONS

1. This Order shall come into operation on 21 September 2011 and may be cited as "The Council of the Borough of Milton Keynes (Central Milton Keynes) (Waiting and Loading Restrictions) Order 2002) Variation Order 2011".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plan annexed to this Order identifies the lengths of roads subject to this Order, provided that where there is any inconsistency between the plan and the Articles it is the wording of the Articles which shall prevail.
4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Central Milton Keynes) (Waiting and Loading Restrictions) Order 2002 and forms part of the Order.

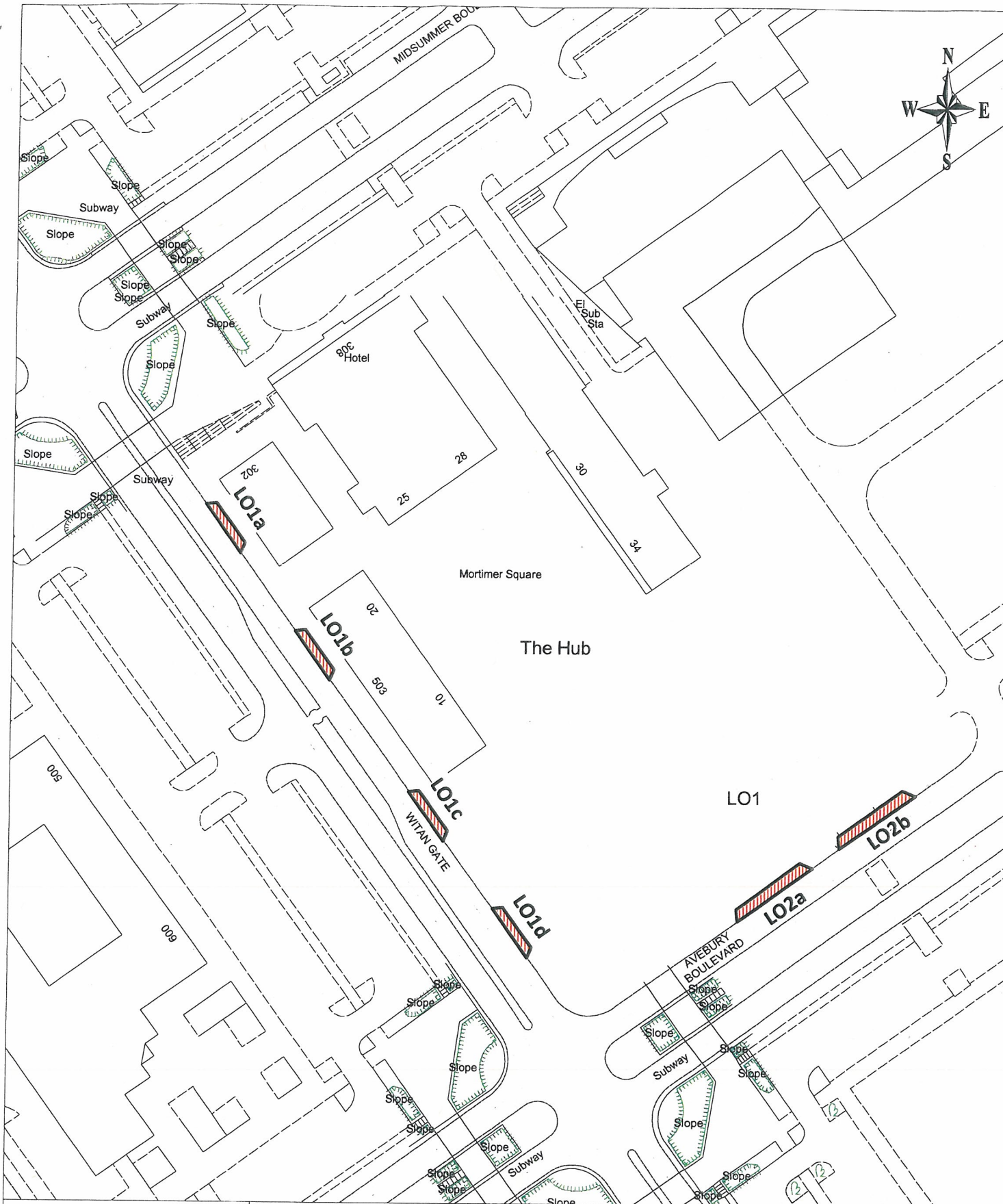
5. A new Schedule 2 is inserted into the Principal Order as follows:-

2) WITAN GATE – NORTH-EAST SIDE

LO1b From a point approximately 82.2 metres south-east of its junction with Midsummer Boulevard, continuing for a distance of approximately 15.1 metres in a south-easterly direction

3) WITAN GATE – NORTH-EAST SIDE

LO1c From a point approximately 110 metres south-east of its junction with Midsummer Boulevard, continuing for a distance of approximately 15.1 metres in a south-easterly direction

4) WITAN GATE – NORTH-EAST SIDE

LO1d From a point approximately 148.4 metres south-east of its junction with Midsummer Boulevard, continuing for a distance of approximately 21.2 metres in a south-easterly direction

5) AVEBURY BOULEVARD – NORTH-WEST SIDE

LO2a From a point approximately 41.5 metres north-east of its junction with Witan Gate, continuing for a distance of approximately 21 metres in a north-easterly direction

6) AVEBURY BOULEVARD – NORTH-WEST SIDE

LO2b From a point approximately 84.5 metres north-east of its junction with Witan Gate, continuing for a distance of approximately 21.2 metres in a north-easterly direction

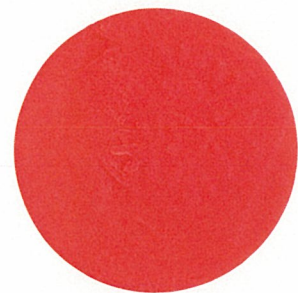
