# THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (CENTRAL MILTON KEYNES) (ON-STREET CAR SHARE AND POOL CAR PARKING PLACES) ORDER 2004) VARIATION ORDER 2011

The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under Sections 45, 46, 49, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

## PART 1 IMPLEMENTATION AND CITATION

- 1. This Order shall come into operation on the 22<sup>nd</sup> September 2011 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Car Share and Pool Car Parking Places) Order 2004) Variation Order 2011".
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- Any plan annexed to this Order identifies the length of road subject to this Order, provided that where there is any inconsistency between the plan and the Articles it is the wording of the Articles which shall prevail.
- 4. Any plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Central Milton Keynes) (On–Street Car Share and Pool Car Parking Places) Order 2004 and forms part of the Order.

#### PART 2

#### **VARIATIONS**

- 5. The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Car Share and Pool Car Parking Places) Order 2004 ("The Principal Order") is varied as provided by the following provisions of this Order:-
- 6. Article 8. (1) in Part 3 of the Principal Order is revoked and replaced with the following;-
  - 8. (1) Each of the lengths of road specified in Schedule 1 to this Order is authorised to be used during the prescribed hours, subject to provisions to this Part of this Order, as a parking place for passenger vehicles, dual purpose vehicles or goods vehicles which display in the relevant position one or more valid car share permits.
- 7. Any reference to "Milton Keynes Sustainable Transport Limited" within the articles of the Principal Order are deleted and replaced with "Milton Keynes Council".
- 8. Any reference to "Milton Keynes Car Share Club" within the articles of the Principal Order are deleted.
- 9. Article 18 (1) in Part 4 of the Principal Order is revoked and replaced with the following;-
  - 18. (1) Any person who is employed by a business located within Central Milton Keynes, who is the user of a passenger vehicle, dual purpose vehicle or goods vehicle may apply to Milton Keynes Council for the issue of a Car Share Permit for use by the user of such vehicle other than a person to whom such vehicle has been let for hire or reward.

### PART 3

#### **REVOCATIONS**

10. The following Order is **HEREBY REVOKED** to the extent stated below;

- 3) Item ESP21 in Schedule 1 IS HEREBY REVOKED IN ITS ENTIRETY.
