The Council of the Borough of Milton Keynes ("the Council") in exercise of the powers of the said Council under Sections 1(1), 2(1) to (3), and (4(2) of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 hereby makes the following Order: -

PART 1

IMPLEMENTATION AND CITATION

- 1. This Order shall come into operation on 15th March 2012 and may be cited as "The Council of the Borough of Milton Keynes (Various Roads within Milton Keynes and Surrounding Areas) (Prohibition of Stopping Outside Schools) Order 2008) Variation Order 2012".
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- 3. The plans annexed to this Order identify the lengths of roads subject to this Order, provided that where there is any inconsistency between the plans and the Articles it is the wording of the Articles which shall prevail.

PART 2

VARIATIONS

- 4. The Council of the Borough of Milton Keynes (Various Roads within Milton Keynes and Surrounding Areas) (Prohibition of Stopping Outside Schools) Order 2008" ("The Principal Order") is varied as provided by the following provisions of this Order:-
- 5. The following item NS102 in Schedule 1 of the Principal order is varied to the extent below:-


Currier Drive, Neath Hill - south-east side

NS102 From a point approximately 12 metres north-east of the centreline of the junction with Tower Drive, continuing for a distance of approximately 40 metres in a north-easterly direction.


6. The following items are inserted into Schedule 1 of the Principal Order as follows:-


Singleton Drive, Grange Farm – south-west side


NS125 From a point approximately 10.1 metres north-west of a point in line with the southern access road into Christ the Sower Primary School car park continuing for a distance of approximately 25.5 metres in a north-westerly direction.



Walton Road, Wavendon - south side

NS128 From a point approximately 6 metres west of the eastern boundary line of property number 37 Walton Road, continuing for a distance of approximately 37.5 metres in an easterly direction.

Old Groveway, Simpson - south-east side

NS129 From a point approximately 1 metre east of the eastern boundary line of property number 41 Old Groveway, continuing for a distance of approximately 25.5 metres in an easterly then northerly direction.
