

**THE COUNCIL OF THE BOROUGH OF MILTON KEYNES
(STATION SQUARE, CENTRAL MILTON KEYNES) (VARIOUS TRAFFIC
RESTRICTIONS) REVOCATION ORDER 2012**

The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under Sections 45, 46, 49 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

PART 1

IMPLEMENTATION, CITATION AND REVOCATIONS

1. This Order shall come into operation on 17 May 2012 and may be cited as "The Council of the Borough of Milton Keynes (Station Square, Central Milton Keynes) (Various Traffic Restrictions) Revocation Order 2012".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order any provisions of any Orders mentioned in the Schedule hereto are hereby revoked to the extent stated in that Schedule.

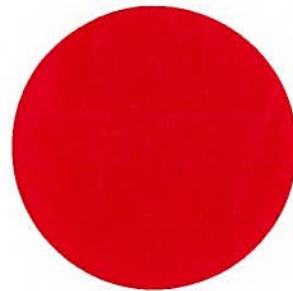
