### <u>PART 1</u>

# **MPLEMENTATION AND CITATION**

- 1. This Order shall come into operation on 10 May 2012 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Standard Rate Pay & Display and Pay by Mobile Phone and Parking Places and Various Permits) Order 2002) Variation Order 2012".
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- 3. Any plans annexed to this Order identify the lengths of roads subject to this Order, provided that where there is any inconsistency between the plans and the Articles it is the wording of the Articles which shall prevail.
- 4. Any plans annexed to this Order are hereby annexed to The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Standard Rate Pay and Display and Pay by Mobile Phone Parking Places and Various Permits) Order 2002 and form part of the Order.
- 5. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order any provisions of any Orders mentioned in Part 3 hereto are hereby revoked to the extent stated in that Part.






