VARIATION ORDER 2012**

The Council of the Borough of Milton Keynes ("the Council") in exercise of the powers of the said Council under Sections 45, 46, 49, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 hereby makes the following Order: -

PART 1

IMPLEMENTATION AND CITATION

1. This Order shall come into operation on 10 May 2012 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Specific and Permit Parking Places) Order 2002) Variation Order 2012".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. Any plans annexed to this Order identify the lengths of roads subject to this Order, provided that where there is any inconsistency between the plans and the Articles it is the wording of the Articles which shall prevail.
4. Any plans annexed to this Order are hereby annexed to The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Standard Rate Pay and Display Parking Places and Various Permits) Order 2002 and form part of the Order.

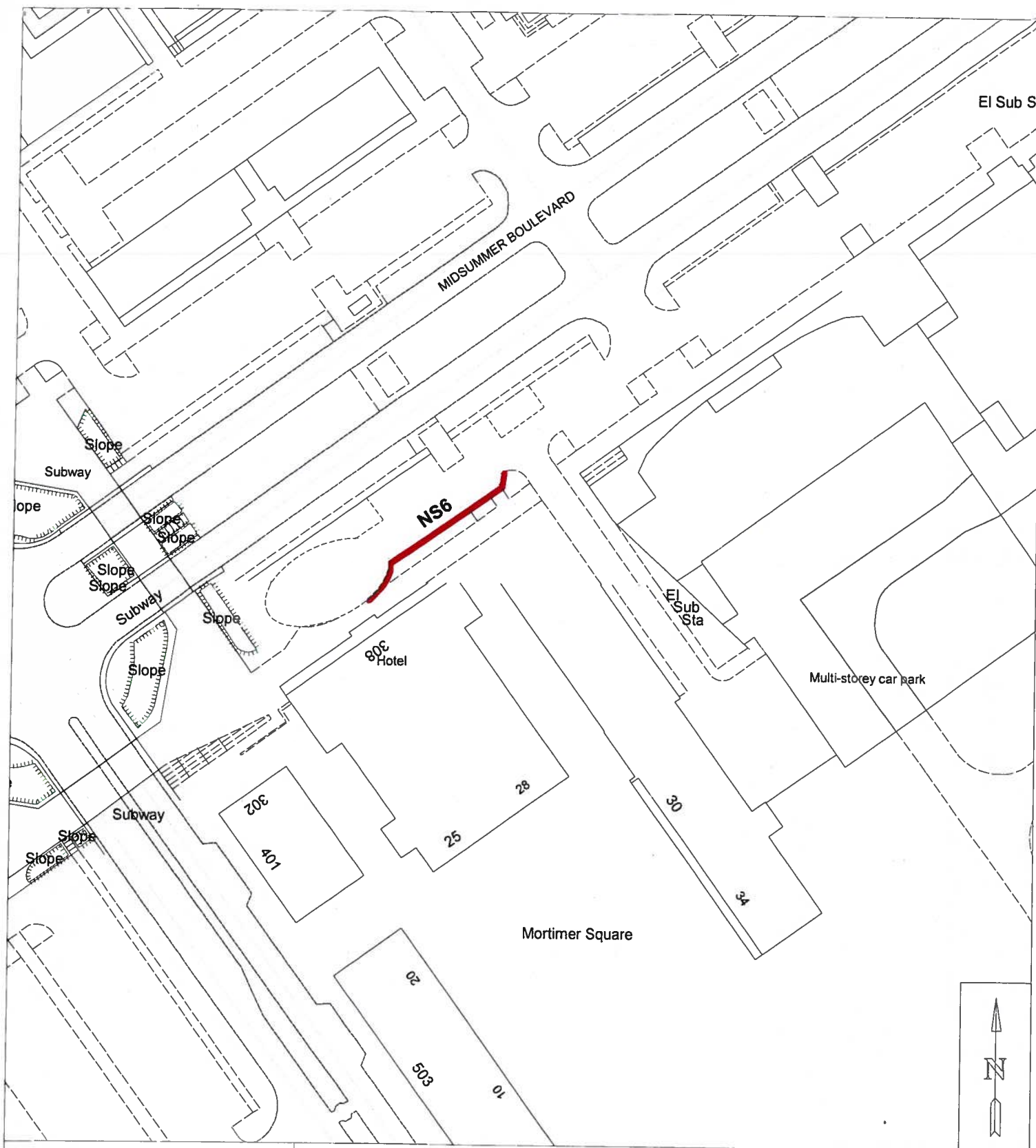
VARIATIONS

NS6 From the access road leading to the multi-storey car park for a distance of approximately 36 metres in a south-westerly direction

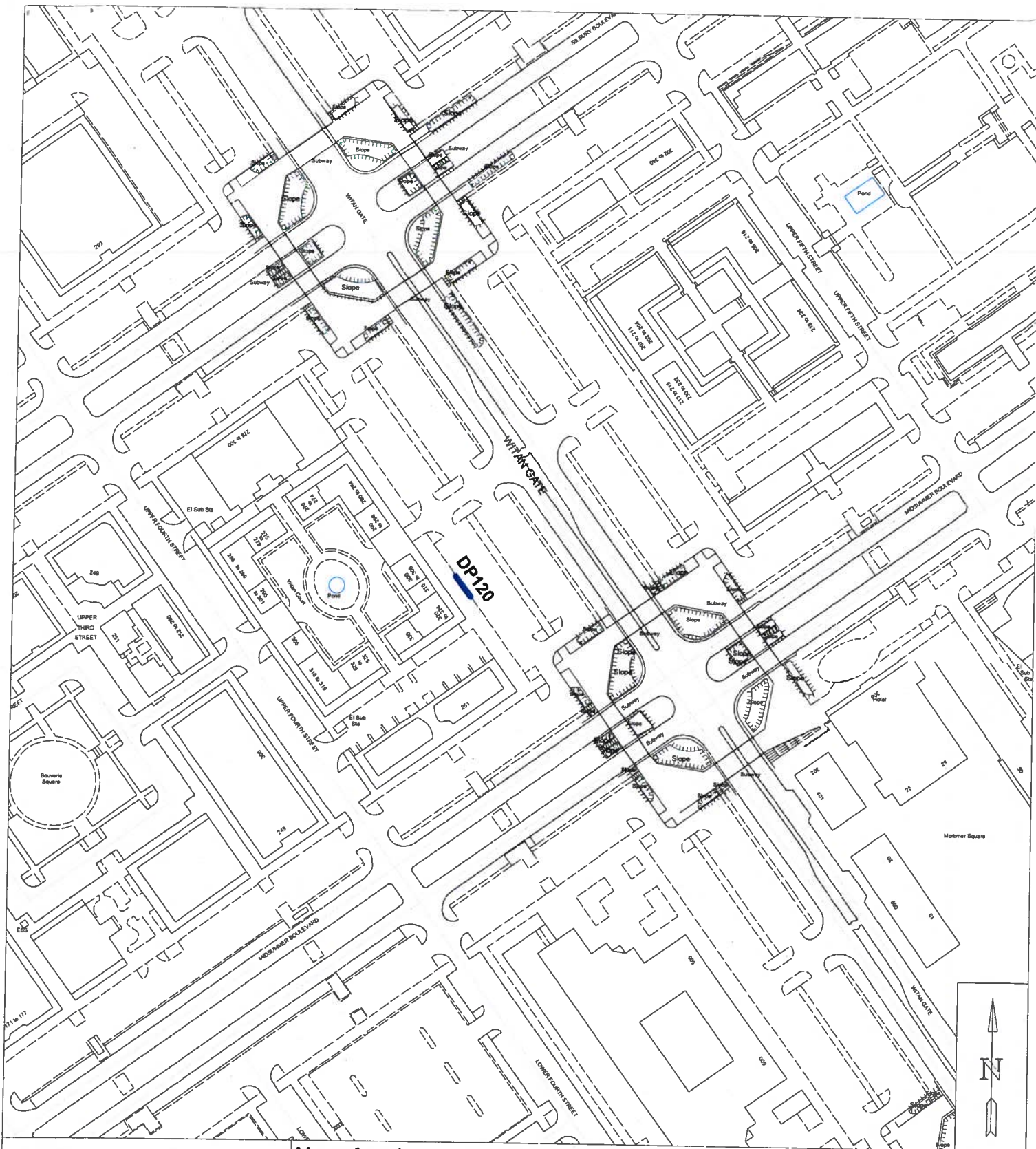

WITAN GATE EAST

THE NORTH-EAST VEHICULAR ACCESSWAY – NORTH-EAST SIDE

PF2 From the north-western kerbline of the entrance to the Police Station to a point approximately 29.5 metres north-west of that point

8. The following items are inserted in Schedule 6 of The Principal Order:-

WITAN GATE WEST

THE SOUTH-WEST VEHICULAR ACCESSWAY – SOUTH-WEST SIDE

DP120 From a point approximately 22 metres south-east of its junction with the south-eastern kerbline of the entrance to Witan Court, for a distance of approximately 7.5 metres in a north-westerly direction

SAXON GATE EAST

DP121 Between 7 and 22 metres east of the eastern kerb of Saxon Gate and between 31 and 36 metres south of the southern kerb of Midsummer Boulevard
