The Council of the Borough of Milton Keynes ("the Council") in exercise of the powers of the said Council under Sections 45, 46, 49, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 hereby makes the following Order: -

PART 1

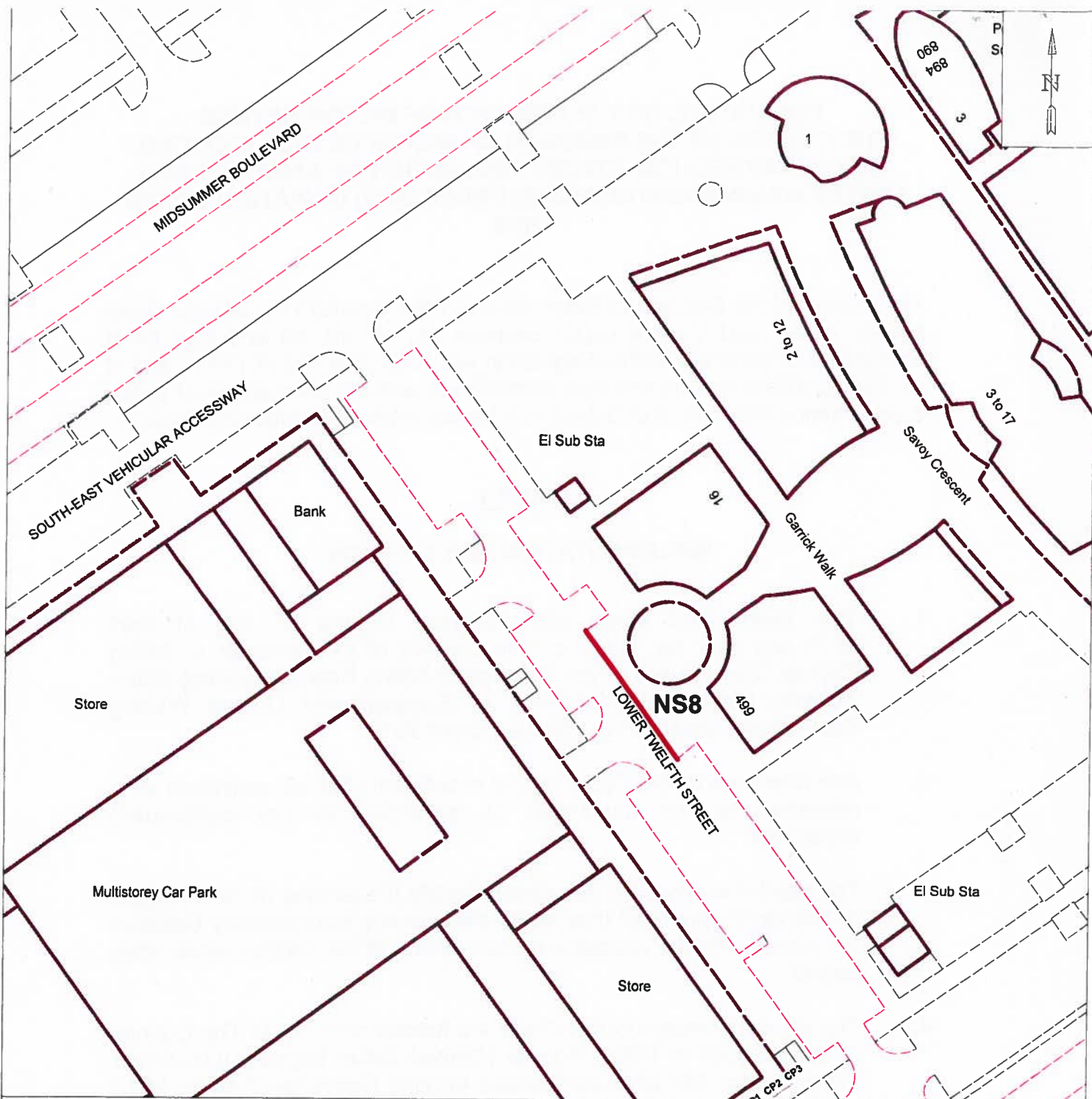
IMPLEMENTATION AND CITATION

1. This Order shall come into operation on the 4th day of April 2013 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Prohibition of Stopping and Limited Waiting Restrictions) Order 2012) Variation Order 2013".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plan(s) annexed to this Order identify the lengths of road subject to this Order, provided that where there is any inconsistency between the plan(s) and the Articles it is the wording of the Articles which shall prevail.
4. The plan(s) annexed to this Order are hereby annexed to The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Prohibition of Stopping and Limited Waiting Restrictions) Order 2012 and form part of the Order.


PART 2

VARIATIONS

5. The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Prohibition of Stopping and Limited Waiting Restrictions) Order 2012 ("The Principal Order") is varied as provided by the following provisions of this Order:-
6. Article 22 of the Principal Order is revoked and replaced with the following :

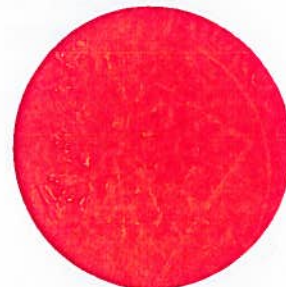

No person shall except with the permission or under the direction of a police officer in uniform, a traffic warden or a civil enforcement officer cause or permit any vehicle except if that vehicle is a taxi to stop during the prescribed days and hours in any of the lengths of road specified in Schedules 4 and 4A hereto.

7. The following SCHEDULE 4A is inserted into the Principal Order:-

SCHEDULE 4A

NO STOPPING EXCEPT TAXIS
BETWEEN 10.00PM AND 6.00AM FRIDAY TO SUNDAY

LOWER TWELFTH STREET, CENTRAL MILTON KEYNES –
NORTH-EAST SIDE

NS8 From a point approximately 69.5 metres south-east of its junction with the south-eastern vehicular accessway of Midsummer Boulevard for a distance of approximately 29.5 metres in a south-easterly direction (6 SPACES)
