

**THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (HIGH STREET AND OLNEY ROAD (PARTS), EMBERTON) (PROHIBITION OF MOTOR VEHICLES EXCEPT FOR ACCESS ONLY) ORDER 2013**

**WHEREAS** the Council of the Borough of Milton Keynes (hereinafter referred to as "the Council") in exercise of their powers under sections 1(1) and 2(1) to (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (the Act of 1984) and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

**PART 1**

**COMMENCEMENT, CITATION AND VARIATIONS**

1. This Order may be cited as The Council of the Borough Of Milton Keynes (High Street and Olney Road (Parts), Emberton) (Prohibition of Motor Vehicles Except for Access Only) Order 2013 and shall come into force on 28 March 2013.
2. The plan annexed to this Order identifies the length of road described in the Schedule to this Order, provided that where there is any inconsistency between the plan and that Schedule, it is the wording of the Schedule which shall prevail.
