

**THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (THE COUNCIL OF THE

OF WAITING RESTRICTIONS) ORDER 2002) VARIATION ORDER 2013**

The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under sections 1(1), 2(1) and (2) and 4(1) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

PART 1

IMPLEMENTATION AND CITATION

1. This Order shall come into operation on 10 October 2013 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes (Various Roads, Wolverton) (Consolidation of Waiting Restrictions) Order 2002) Variation Order 2013".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plan and the Articles it is the wording of the Articles which shall prevail.
4. The plan annexed to this Order is hereby annexed to The Council Of The Borough Of Milton Keynes (Various Roads, Wolverton) (Consolidation Of Waiting Restrictions) Order 2002 and forms part of the Order.

PART 2

VARIATIONS



5. The Council Of The Borough Of Milton Keynes (Various Roads, Wolverton) (Consolidation Of Waiting Restrictions) Order 2002 ("The Principal Order") is varied as provided by the following provisions of this Order:-

Item LW3 in Schedule 1 of the Principal Order is removed and replaced with the following:-

CHURCH STREET, WOLVERTON
NORTH SIDE

LW3(i) From a point approximately 11 metres east of Radcliffe Street for a distance of approximately 85.5 metres in an easterly direction

LW3(ii) From a point approximately 9.5 metres south-west of Creed Street for a distance of approximately 58.5 metres in a south-westerly direction
