The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under Sections 1(1), 2(1) and (2), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

PART 1

IMPLEMENTATION, CITATION AND DEFINITIONS

- This Order shall come into operation on the 16th day of January 2014 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Various Roads, Newport Pagnell) (Consolidation of Parking and Waiting Restrictions) Order 2002) Variation Order 2014".
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- The plans annexed to this Order identify the lengths of roads subject to this Order, provided that where there is any inconsistency between the plans and the Schedules it is the wording of the Schedules which shall prevail.
- 4. The plans annexed to this Order are hereby annexed to The Council of the Borough of Milton Keynes (Various Roads, Newport Pagnell) (Consolidation of Parking and Waiting Restrictions) Order 2002 and form part of that Order.

PART 2

VARIATIONS

- 5. The Council of the Borough of Milton Keynes (Various Roads, Newport Pagnell) (Consolidation of Parking and Waiting Restrictions) Order 2002 ("The Principal Order") is varied as provided by the following provisions of this Order:-
- 6. Item NW20 in Schedule 1 of the Principal Order is revoked and replaced with the following:-


GREENFIELD ROAD, NEWPORT PAGNELL- SOUTH-WEST SIDE

NW20 From a point in line with the south-eastern kerbline of Linford Avenue for a distance of 48.1 metres in a south-easterly direction.

- 7. The following items are inserted into Schedule 1 of the Principal Order as follows:-
 - LINFORD AVENUE, NEWPORT PAGNELL SOUTH-EAST SIDE
 NW101 From a point in line with the south-western kerbline of Portfields
 Road for a distance of 12 metres in a south-westerly direction.
 - NW102 From a point in line with the north-eastern kerbline of Portfields Road for a distance of 12 metres in a north-easterly direction.
 - 2) PORTFIELDS ROAD, NEWPORT PAGNELL BOTH SIDES NW103 From a point in line with the south-eastern kerbline of Linford Avenue for a distance of 12 metres in a south-easterly direction.
 - 3) THE ACCESS ROAD LEADING TO THE LOCAL SHOPS AND ABBOTS WOOD, NEWPORT PAGNELL NORTH SIDE
 NW104 From a point 4.8 metres east of a point in line with the western

boundary wall of number 81 Abbotts Wood for distance of 24.2 metres in a westerly direction.





4) THE ACCESS ROAD LEADING TO THE LOCAL SHOPS AND ABBOTS WOOD, NEWPORT PAGNELL - SOUTH SIDE

NW105 From a point 12.6 metres east of a point in line with the western boundary wall of number 81 Abbotts Wood for distance of 44.3 metres in a westerly, southerly, westerly, northerly and westerly direction.
